For residential shipments, if no Delivery Signature Option is selected during shipment creation and no one is available to receive the package, FedEx may deliver it to a secure location at the recipient's address, where permitted by local law.</p> <p>1. No Signature Required: FedEx will attempt to obtain a signature at the delivery address. If no one is available to sign, FedEx will deliver the package in a safe place without obtaining signature.</p> <p>2. Indirect Signature Required: FedEx will obtain a signature from someone at the delivery address or from somebody nearby, such as a neighbour or building manager. The recipient has the option to utilise any FedEx-approved means to authorise the shipment to be released without anyone present.</p> <p>3. Direct Signature Required: FedEx will obtain a signature from someone at the delivery address only. If no one is available to sign, FedEx will attempt to redeliver the package.</p> <p>4.
