FedEx offers a range of options for your shipments which may incur additional fees or surcharges. Below you can find more information on these extra services and other useful shipping information.

Value Added Services⁽¹⁾⁽²⁾

You can customise your FedEx services to your needs (or the needs of your recipients) with our value added services. The following are descriptions of the fees applicable to value added services.

<p>FedEx® Delivery Signature Options</p> <p>The following delivery signature options⁽⁸⁾ may be chosen at the time of booking your shipment. For residential shipments, if no Delivery Signature Option is selected during shipment creation and no one is available to receive the package, FedEx may deliver it to a secure location at the recipient's address, where permitted by local law.</p> <p>1. No Signature Required: FedEx will attempt to obtain a signature at the delivery address. If no one is available to sign, FedEx will deliver the package in a safe place without obtaining signature.</p> <p>2. Indirect Signature Required: FedEx will obtain a signature from someone at the delivery address or from somebody nearby, such as a neighbour or building manager. The recipient has the option to utilise any FedEx-approved means to authorise the shipment to be released without anyone present.</p> <p>3. Direct Signature Required: FedEx will obtain a signature from someone at the delivery address only. If no one is available to sign, FedEx will attempt to redeliver the package.</p> <p>4. Additional Handling Surcharge Package Services A surcharge applies per package or piece that: Dimension <ul style="list-style-type: none">measures greater than 121 centimetres along its longest side;measures greater than 76 centimetres along its second-longest side;measures greater than 266 centimetres in length and girth - the length and girth is length plus (two times the height) plus (two times the width);measures greater than 169 901 cubic centimetres in volume (length times width times height). Packages that qualify for AHS – Dimension will be subject to 18 kg minimum billable weight. IMPORTANT: If a FedEx package is subject to an Oversize Charge or AHS – Packaging, and also meets the criteria for AHS – Dimension, the minimum billable weight of 18 kg will still apply. This means that this condition is enforced even if AHS - Dimension itself is not charged. Weight⁽⁹⁾ <ul style="list-style-type: none">has an actual weight greater than 25 kg. Package shape and dimensions may change during transit, which can affect the package's dimensional weight and surcharge eligibility. If the package shape and dimensions change during transit, FedEx may make appropriate adjustments to the charges at any time. This surcharge applies per piece even if multiple pieces are bundled in a shipment. If a non-standard package is eligible for two or all three Additional Handling Surcharges (Dimension, Weight, or Packaging), only the one with highest charge will apply. FedEx reserves the right to assess Additional Handling charges for packages that require special handling or that require FedEx to apply additional packaging during transit. Freight Services A surcharge applies to any freight handling unit that measures greater than 157 centimetres ⁽¹⁰⁾ along its longest side. This surcharge applies on a per-freight-handling-unit basis even if multiple pieces of freight are bundled in a shipment. Examples include, but are not limited to, non-stackable freight handling units that: 1) do not have a flat and stable top or base, 2) may be damaged if another piece is loaded on them, or 3) have flat and stable loading surfaces but are too narrow to safely and securely support other freight handling units (e.g. 1-2 barrels or drums). A surcharge also applies to any freight handling unit identified by the shipper as non-stackable.
