



## Wineries Wine Shipping State Pairing Guide (For Licensed Wineries Only)

The Wineries Wine Shipping State Pairing Guide is a resource for licensed wineries that have executed a FedEx Alcohol Shipping Agreement with FedEx and want to tender packages of wine to FedEx Express and FedEx Ground for transport to consumers. A consumer shipment includes any shipment destined to a residence. FedEx only accepts shipments of wine from licensed shippers that have executed a FedEx Alcohol Shipping Agreement with FedEx.

The terms of shipping are governed by the FedEx Service Guide, FedEx Alcohol Shipping Agreement, and any applicable rate agreement. The shipper is responsible for knowing and complying with all applicable laws and regulations in both the origin and destination states. The shipper is also responsible for determining whether they and the consignee meet all applicable requirements and whether such a shipment may be legally transported by common carrier.

This guide does not apply to shipments made by retailers. Retailers should refer to the Retailers Wine Shipping State Pairing Guide.

This guide does not constitute legal advice and only reflects FedEx Express and FedEx Ground policies regarding where FedEx will transport wine shipments on behalf of retail customers. Shippers may need a license or permit to ship into certain states. Please consult an attorney for information regarding the wine shipping laws in each state.

Please contact the appropriate state alcohol beverage commission for more information.

<sup>3</sup>Direct Shipper permits are required; contact New Hampshire Liquor Commission (603-271-8543). Alcohol shipments are prohibited to dry town: Ellsworth.
