



Disbursement Fee

(also known as Advancement Fee / Duty and Tax Advancement Fee)

FedEx may disburse any applicable duties, taxes and other regulatory charges on your behalf, to ensure timely payment to the customs agency. The payer is responsible for the total amount disbursed, plus an additional fee as published in the charges below.

Local clarifications:

- **Australia:** This fee is applicable for customers who settle regulatory charges by FedEx account.
- **Thailand:** The service covers any import of all shipments which FedEx and TNT had paid advancing customs duty and tax on behalf of those importers.
- **Cambodia:** In the event we disburse duties and taxes on any given shipment to a customs agency, the payer will be assessed an ancillary clearance service fee based on a flat rate or on a percentage of the total amount disbursed.

Reimbursement on Delivery Fee (Duty Tax Handling Fee)

(also referred to Reimbursement on Delivery Fee / Duty Handling Fee)

The fee that FedEx will charge to compensate FedEx for operating a direct payment process allowing release of shipments and payment of customs charges for customers who do not have a FedEx account number.

Local clarifications:

- **Australia:** This fee is applicable when FedEx has processed any applicable duties, taxes and/or other regulatory charges on behalf of customers who do not have a FedEx account number.
- **New Zealand:** Applies to NZ import shipments when the customer does not have a FedEx account to settle duty, tax and other regulatory fees.
