I. Informal Entry

► Export Informal-Clearance procedure:

Export List-Clearance procedure: The term "List-Clearance Procedure" refers to an exceptional procedure applied to export customs clearance of personal goods that are not reflected in trade statistics, or goods that are not subject to a customs refund and do not require formal customs procedures. (Non-issuance of an export permit)

▶ Export Informal-clearance criteria:

When the price of goods (Free on Board) is less than KRW 2 million (However, export goods subject to confirmation by a Customs collector are excluded)

▶ Export goods subject to confirmation by a Customs collector

▶ When an export declaration is needed

- ▷ When an export enterprise (i.e., a business entity) needs to be recognized for its export performance
- > When it is recognized as overseas sales and intends to provide evidentiary documents on the price of foreign currency after export
- > When exported goods are carried into again due to claims, etc.
- ▶ When a person wants to receive an individual refund or a temporary fixed-rate refund under the Act on Special Cases Concerning the Refund of Customs at the time of export
- > When a person needs to get a zero-rate tax invoice based on a purchase confirmation

II. CITES

- ▶ International endangered species apply to wildlife, wild plants, and their tissues, extracts, and processed products, as stipulated in the annex of the convention regulated by the Washington Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES).
- ▶ It is important to identify the scientific name of the species in order to determine whether this is an animal or plant listed in CITES.
- ▶ Please check annex I, II, and III of the convention to confirm whether the goods you are exporting are subject to CITES.
- ▶ Health enhancing supplements or cosmetics may contain extracts from animals and plants listed by CITES.

III. Prohibited Items

Article 234 (Prohibition on Export and Import): Any of the following goods shall not be exported or imported:

- ▶ Books, publications, drawings, movies, records, videos, sculptures, or other goods equivalent thereto that disrupt the order of the Constitution, or the order of public well-being
- ▶ Goods used to divulge confidential government information or to engage in espionage activities
- ► Counterfeits, forged goods, or counterfeit money, bonds, or other securities

V. Mandatory Business and Personal Customs Clearance Code

You must present the customs clearance code issued from the Korea Customs Service for customs clearance of imports and exports. An importer, exporter, or agent should secure the respective customs clearance code in advance to avoid delays in customs clearance. **Business Customs Clearance Code** (Ex.: Business 1981017)

- ▶ New issuance can be carried out via mobile phone authentication under the subscriber's name, authentication via an accredited certificate, or simplified authentication. (If Exporter or Import is foreigner, Passport number, Nationality, Full name can replace the Personal Customs Clearance Code)
