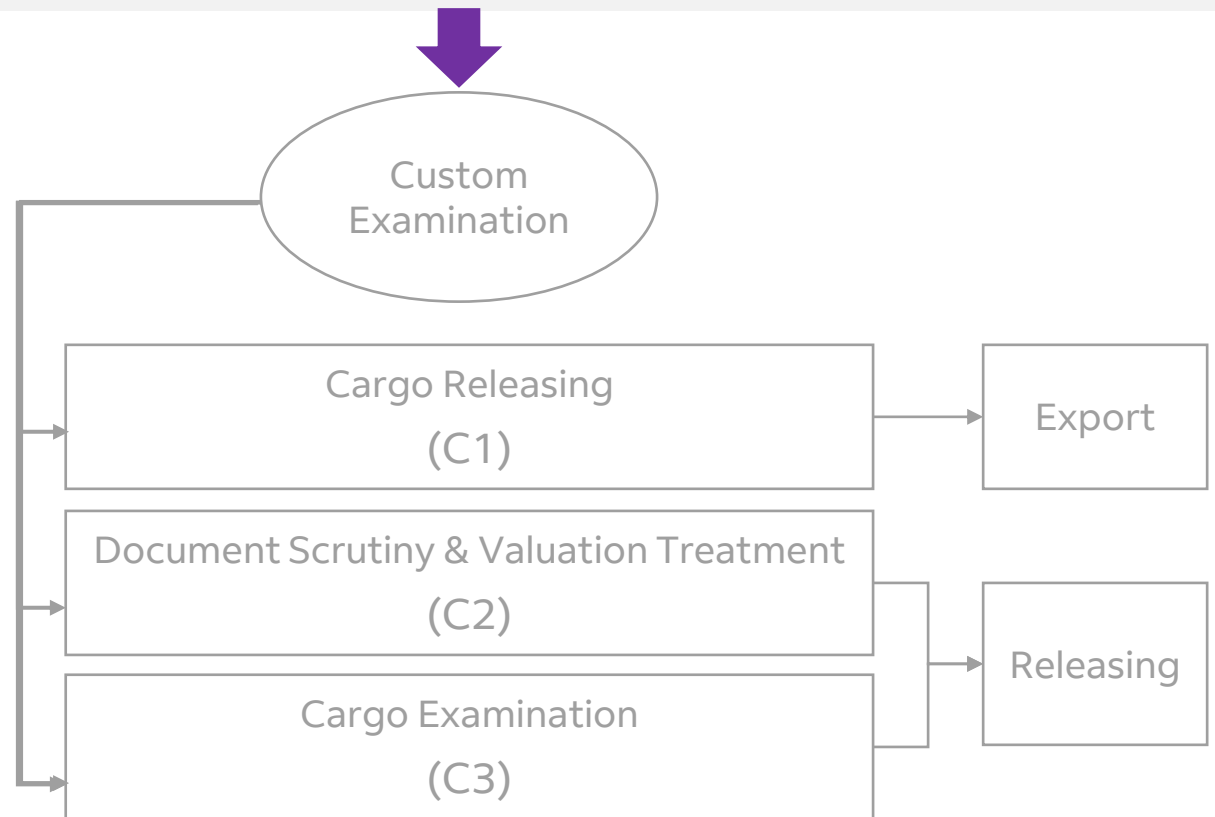
Express Export Clearance Flow

Submit Export Application of the Shipment, Categorizations of express shipments:

X6 : Documents

X7 : Low-value, FOB¹ under TWD50,000 (Non-Formal Entry, Limited to products of made in TW, non-re-export, non-refundable/bonded, and those who meet the import and export regulations)

X8 : High-Value, FOB¹ above TWD50,000 (Formal Entry)



¹ FOB: "Free On Board" is a shipping term used in retail to indicate who is responsible for paying transportation charges. It is the location where ownership of the merchandise transfers from seller to buyer.

In order to comply with the customs regulations of Taiwan, shippers tendering a personal export shipment must provide: Power of Attorney (POA); and copy of the shipper's national identification card (showing both sides) or passport, to facilitate customs inspection.

¹The declaration value above are all FOB. And if the declaration Value exceeds NTD 50,000 (including 50,000), the formal entry is required.

²Relevant documents can be found [here](#). The documents required for customs clearance may vary for different category of products, the final approve from customs should be prevail.

³Both the commercial invoice and the packing list must be in 1 original and 1 copy.



Tips to Expedite the Process



Follow steps to arrange formal export declaration

1. Fill out commercial invoice with correct air waybill number, Shipper/Consignee name and phone number.
2. Please fax (02-81783178) or email (edd@fedex.com) your documents to Export Documentation Dept. before shipping (1 hour in advance).
3. Schedule pickup at fedex.com.



Double check the information on the Air waybill and Commercial Invoices

1. Shipper/Consignee Name, Telephone and extension number.
2. Country of origin / Country of manufacture.
3. Full description of goods (What is it made of? / What is it used for? / What is it a component of? / Declared value)
4. Please add page number on your commercial invoice if multi-page (Example: 1 of 2, 2 of 2).



Double check the restrictions when arrange a same day flight for packages without customs clearance¹

1. Weight per package less than 68kg
2. Declared value less than NT\$50,000.
3. Excluding the length, Width*Height should be smaller than 90*75cm.



International Heavy Freight² (Formal declaration is required)

1. Weight per package up to 68kg but less than 1,000kg.
2. For the size and weight restrictions, please contact customer service (0800-075-075).
3. For Air cargo space booking, please contact customer service 1 day and no later than 17:00 in advance. Also, formal export declaration is needed..



Power of Attorney (Long-term Authorization)

It is recommended to apply long-term authorization to entrust FedEx for customs declaration. Save time, money and paper when you prepare your customs documents. If your company has Corporate Certificate of MOEACA or Citizen Digital Certificate, you can apply online : <http://portal.sw.nat.gov.tw/PPL/> .

¹ Package and Documents must be well-prepared before cut-off time

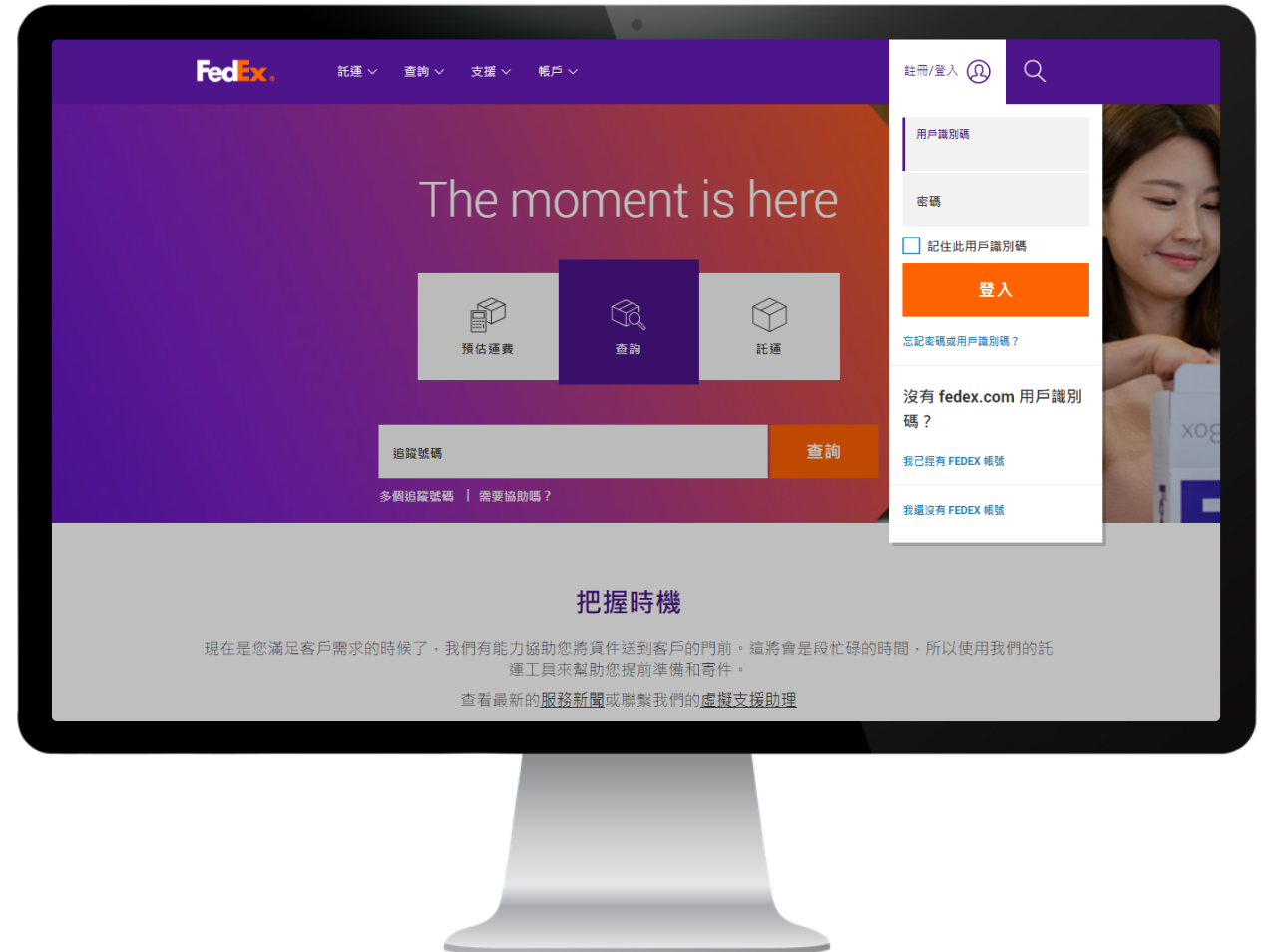

Frequently Used Terminology



Export Declaration Form

Customs form completed and submitted by an exporter at the port of export, it is meant to serve two major purposes:

1. to provide information on amount, nature, and value of exports to the statistical office for compilation of foreign trade data, and
2. to serve as an export control document.



Terms of Trade

➤ **Free on Board (FOB) :**

The seller delivers the goods on board the vessel nominated by the buyer at the named port of shipment or procures the goods already so delivered. The risk of loss of or damage to the goods passes when the goods are on board the vessel, and the buyer bears all costs from that moment onwards.

➤ **Free Alongside Ship (FAS) :**

The seller delivers when the goods are placed alongside the vessel (e.g., on a quay or a barge) nominated by the buyer at the named port of shipment. The risk of loss of or damage to the goods passes when the goods are alongside the ship, and the buyer bears all costs from that moment onwards.

➤ **Cost and Freight (CFR) :**

The seller delivers the goods on board the vessel or procures the goods already so delivered. The risk of loss of or damage to the goods passes when the goods are on board the vessel. the seller must contract for and pay the costs and freight necessary to bring the goods to the named port of destination.

➤ **Cost Insurance and Freight (CIF) :**

The seller delivers the goods on board the vessel or procures the goods already so delivered. The risk of loss of or damage to the goods passes when the goods are on board the vessel. The seller must contract for and pay the costs and freight necessary to bring the goods to the named port of destination.

➤ **EX works (EXW) :**

The seller delivers when it places the goods at the disposal of the buyer at the seller's premises or at another named place (i.e. Works, factory, warehouse, etc.). The seller does not need to load the goods on any collecting vehicle, nor does it need to clear the goods for export, where such clearance is applicable.

➤ **Cost and Insurance (C&I) :**

The price invoiced or quoted by a seller for a shipment includes insurance charges, but does not include freight charges. In comparison, CIF includes freight charges.

Frequently Asked Questions

Questions	Answers
Why do I need to declare my export shipment?	Shipments, baggage and postal items shall be declared to the Customs by the owner or his agent when entering or leaving the border, and the relevant bill of lading, packing list, invoice and relevant export/ import permit shall be submitted for inspection.
What is Clearance?	<ul style="list-style-type: none">• Also known as customs clearance, it means that import and export goods, transshipment goods into/out of a country's customs or borders must be declared to the customs, go through the prescribed formalities, fulfill various legal obligations, and handle customs declaration, inspection, taxation, release, etc. After the goods can be released, the owner or the applicant can pick up the shipment.• Likewise, all kinds of transportation vehicles carrying goods for import and export must also be declared to the customs and approved by the customs. During the customs clearance period, whether it is import, export or transshipment, it is under the supervision of the customs and is not allowed to circulate freely.
Why do I need to provide power of attorney (POA)?	<ul style="list-style-type: none">• It is required based on Article 22, Item 1 of the Tariff Law.• Customs declaration, tax payment, etc. of the goods shall be entrusted to the customs broker for processing. The applications submitted to the customs shall be reviewed by the special customs declaration personnel.
What are the required documents for Clearance?	<ul style="list-style-type: none">• Air Way Bill• Commercial Invoice• Power of Attorney: POA or LPOA• Export Declaration Form• Packing List• Other additional document and certifications required by Customs
