

1. Please download app “EZ WAY” and enter

3. Please enter “Paper Letter of Authorization”, still Confirm regarding RNA is not yet open for foreigner. And select “FedEx”

The “HAWB” is your shipment FedEx air waybill 12 digit tracking number

The “ID Card No.” is your passport number or ARC number.

The “Name” should be as same as your passport name

The “Date” is the date you create the POA

4b. For “Upload Picture” section:


Please upload your passport photo in both ID Card (Front) and (Back), and signature on your screen.


