Smooth shipping during Mid-Autumn Festival

As Mid-Autumn Festival approaches, FedEx is your easy choice to seamlessly send mooncakes to loved ones around the world. Check out these tips for ensuring a stress-free shipping experience during this festive season:

(Applicable for cash shipment only)Prior notice is required per the FDA requirement except for "Individual to Individual food items for non-commercial/non-business purposes."May require the Social Security Number (SSN) of the U.S. recipient for certain shipments imported in the United States.Meat and dairy products are subject to U.S. Department of Agriculture Compliance; other food products are subject to U.S. Food and Drug Administration compliance.Invoice with “FS” in front of the description on commercial invoice, and manufacturer’s name, address.All shipping documents supporting U.S. Import shipments must be completed in English only.Only mooncake (without egg / with no egg ingredients) can be shipped into the United States. Taiwan	✓	✗	✓	✓	<ul style="list-style-type: none"> Description of goods : Personal gift of mooncake without meat To Individual – It's limited to a maximum weight of 6 kilograms and total value of less than USD 1,000 per item. To Company – Regardless of weight or value, an application for an import approval from the Ministry of Health and Welfare's FDA is required for all imports. The sender must declare the brand , ingredients details of the mooncakes on the commercial invoice. The photocopy of the outer packaging of the ingredient is required during customs inspection. If it contains egg yolk, it must be fully cooked. Individual recipient please register with EZWAY which allows the individual recipient to validate import shipments as being legitimate to facilitate customs clearance process. The moon cake to Individual recipients must ensure that the Airway and commercial invoice include the following information: Full English name and Chinese name, mobile number and email. For those who are not accessible to EZWAY authorization, individual POA with the recipient's signature and all relevant personal information is required to be provided along with the front and back copy of citizenship ID/ passport / ARC. Mooncakes with a customs value exceeding NT\$2,000 will be subject to a 20% customs duty and a 5% VAT. 	The import of mooncakes containing meat ingredients and originating from China is prohibited.

Important Notes:

- Duties/Taxes will be assessed. The consignee is required to pay for the duties and taxes incurred at destination.
- Any articles susceptible to damage due to conditions that may be encountered during transportation, such as changes in temperature or atmospheric pressure, must be adequately protected by proper packaging. FedEx assumes no liability for perishables or commodities that could be damaged by exposure to heat or cold.
- The mooncake should be in its original packing with box (if any) and additional packing material will be provided by FedEx station. We recommend bringing along the original receipt when dropping off your mooncakes.
- Transit time may vary due to the longer custom clearance process associated with food shipments
- The shipper is responsible for ensuring that all goods are shipped in full compliance with applicable customs regulations. This includes providing all necessary documentation and accurate information required for customs clearance. For further details, please refer to our [Standard Conditions of Carriage](#).
