



Looking at Shipping Personal Protective Equipment?

We have some shipping tips to help you prepare.

When it comes to shipping, it is key to stay updated with current customs regulatory requirements and check that your documents are complete. Getting all these together usually takes time and effort, that is why we are sharing some tips on these customs regulatory requirements for shipping of items like sanitizers for personal use from South Korea to help in your preparation.

General Frequently Asked Questions (FAQs)

1. What kind of personal protective equipment (PPE) is covered in this shipping guide?

This shipping guide provides information on exporting of masks, alcohol wipes and sanitizers from South Korea for personal use.

2. Can individuals send PPE such as masks to other countries/territories?

Certificated masks (i.e. surgical and dental masks, and masks with KF80/84/99 mark) cannot be exported. No more than 100 pieces of normal masks (i.e. uncertificated masks made of cotton or nylon) can be exported via personal account.

Export of alcohol wipes and sanitizer is subject to IATA shipping requirements. For sanitizers, each personal account shipment is limited to 499 pieces. For details, please refer to this guide.

3. Will my PPE shipments for personal use be subjected to tax?

Yes, if the product exceeds certain amount (amount varies across countries).

4. How may I send my PPE shipments?

For FedEx customers

You may drop off your PPE shipments at our centers, [click here](#) to find our locations. Else you may arrange through the FedEx pick-up service with proper packaging.

For TNT customers

You are recommended to use FedEx services for PPE shipments.

5. May I pack the items with my own packaging?

Alcohol sanitizers and alcohol wipes must be kept in their original packaging. It is also required to place them in a box for shipping.

6. Will my shipments be subject to customs inspection?

Yes, it will be subject to customs inspection and customs may also open the package to ensure that it meets the packaging requirement.

7. Do I need a FedEx account in order to ship?

For FedEx customers

Yes, cash and credit cards are both accepted. Alternatively, you could provide consignee's FedEx account. If you ship with a FedEx account, you will be eligible to enjoy the discount below:

- Applicable to new corporate customers only, Register a FedEx account to enjoy 40% off shipment charges. Terms and conditions to apply (click [here](#)).

For TNT customers

If you already have a TNT account, you can use it for shipping. If not, you are encouraged to open an account with FedEx to enjoy new account discount offers.

1. How can I tell the difference between FDA-regulated PPE and PPE that the FDA does not regulate?

The determining factor is its intended use. If the products are intended to prevent, mitigate or treat a disease or illness, then the FDA regulates those products. If the intended use is for general-purpose protection or industrial use (products that are not intended to prevent disease or illness), then they are not regulated by FDA.

A clear description that shows the intended use of the goods is of utmost importance. For example, if N95 respirators are being imported for use by medical personnel, then a good description would be 'N95 respirators for use by medical personnel'.

Shipping Tips for FedEx

#1 Sanitizers and alcohol wipes must come in the original packaging



Hand Sanitizer

- Each bottle should not be more than 30ml
- Each shipment should not be more than 500ml or 16 bottles in a package



Mask

- Certificated masks (i.e. surgical and dental masks, and masks with KF80/84/99 mark), cannot be exported.
- No more than 100 pieces of normal masks (i.e. uncertificated masks made of cotton or nylon) can be exported via personal account.



Alcohol wipe / swab

- Each piece should not be more than 30g
- Each package should be limited to 499 pieces or 500g in weight.

Steps for shipping via FedEx Ship Manager® (no manual AWB surcharge):

- Check whether destination country accepts shipment from our website ([link](#))
- Log-into/ register at fedex.com to input the shipment info on the air waybill (AWB) ([link](#))
- The commercial invoice could be automatically created, or you could customize for your own use
