

An exemption letter issued by BNPB can be applied to the following items.

For 15 of the most common COVID-19 related items, BNPB will automatically exempt the goods if the quantity is below a certain threshold. The items and quantity limits are listed below.

In order to facilitate importation of the COVID-19 related goods, Customs has issued Finance Ministry Decree No 34/PMK.04.2020. It states that import shipments of COVID-19 related items falling under 73 HS codes with a Free on Board (FOB) value of less than USD 500, will be granted free import duty and tax if the importer can provide an Indonesian tax ID (NPWP). If the shipment's FOB value is more than USD 500, the importer must apply to customs for approval to get free import tax granted for both commercial and non-commercial shipments
