

FedExCup® Getaway Sweepstakes Official Rules (“Rules”) No Purchase Necessary to Enter or to Win.

1. **Eligibility:** The FedExCup Getaway Sweepstakes (“Sweepstakes”) is open to legal residents of the fifty (50) United States, the District of Columbia and Canada who have reached the age of majority in their state/jurisdiction of residence as of the date of entry. The Sweepstakes is also open to businesses that are lawfully registered and operated in the fifty (50) United States, the District of Columbia and Canada. The business owners or authorized employees who enter on behalf of the business must be legal residents of the 50 United States, the District of Columbia (“U.S.”) or Canada who have reached the age of majority in their state/jurisdiction of residence as of date of entry. Employees of Federal Express Corporation (“Sponsor”), Don Jagoda Associates (“Administrator”), Counterpart Communication Design, PGA TOUR® ENTERPRISES, LLC, and each of their respective parent and affiliate companies (collectively with Sponsor, Administrator, Counterpart Communication Design, PGA TOUR ENTERPRISES, LLC the “Promotion Parties”) as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Subject to all applicable laws and regulations. Void outside the 50 United States, the District of Columbia, Canada and where prohibited. Eligible persons/businesses who participate in the Sweepstakes will be referred to as “Participant”, “you” or “your” in these Rules. Participation constitutes Participant’s full and unconditional agreement to these Rules and Sponsor’s and Administrator’s decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. FedEx account (if you have one) must be in good standing, as determined by Sponsor in its sole discretion.
2. **Sweepstakes Timing:** Sweepstakes begins at 10 a.m. Eastern Time (“ET”) on August 11, 2026 and ends at 5 p.m. ET on September 18, 2026 (“Sweepstakes Period”). The Mid-Way prize period begins at 10 a.m. ET on August 11, 2026 and ends at 5 p.m. ET on August 28, 2026 (“Mid-Way Prize Period”).
3. **How to Enter the Sweepstakes:** During the Sweepstakes Period, as an eligible Participant with a FedEx account, you can register at www.fedex.ca/fedexcupsweeps by completing all required fields of the onscreen registration form, including providing your individual or business FedEx account number, to receive one (1) entry into the Sweepstakes (“Registration Entry”). Multiple Participants can be registered with the same FedEx account number. An email address may only be used once. You may not enter the same email address with different FedEx accounts. By registering a FedEx account number as an individual or as a business, you affirm and acknowledge that you are an owner or authorized representative of the FedEx account number and are authorized to enter using such account number. If you do not have a FedEx account and do not wish to sign up for one, but do wish to enter the Sweepstakes, you may hand-print your full name, business name (if applicable) and email address on a 3" x 5" piece of paper and mail it in a separate hand-addressed, stamped envelope with sufficient postage to be mailed to the U.S. to: The FedExCup Getaway Sweepstakes Registration Entry, P.O. Box 7748, Melville, NY 11775-7748 USA. Limit one (1) Registration Entry per Participant, regardless of entry method. Mail-in Registration Entries must be complete to be eligible and must be postmarked by September 18, 2026, and received by September 25, 2026, to be eligible for the Grand, First and Second Prize drawing. To be eligible to win a Mid-Way Prize, Registration Entries must be postmarked by August 28, 2026 and received by September 4, 2026. Mechanically reproduced or automated mail-in Registration Entries are not eligible.

There are three (3) ways to earn bonus entries (“Bonus Entries”) after a Registration Entry is obtained:

- 1) Making a Qualifying FedEx Shipment: Once registered, Participants may earn Bonus Entries (as described below) by completing qualifying FedEx shipments as listed in the chart below (“shipments”) using a valid and eligible FedEx account number that was registered for the Sweepstakes and is in good standing, as determined by the Sponsor in its sole discretion.

- 2) Mail-in Entry: If you received a Registration Entry via your FedEx account number, you may earn Bonus Entries by hand-printing your full name, business name (if applicable), FedEx account number and email address on a 3" x 5" piece of paper and mailing it in a separate hand-addressed, stamped envelope with sufficient postage to be mailed to the U.S. to: The FedExCup Getaway Sweepstakes-Bonus Entry, P.O. Box 7748, Melville, NY 11775-7748 USA. If you do not have a FedEx account number and have sent a mail-in Registration Entry, you may earn Bonus Entries by hand-printing your full name, business name (if applicable) and email address on a 3" x 5" piece of paper and mailing it in a separate hand-addressed, stamped envelope with sufficient postage to be mailed to the U.S. to: The FedExCup Getaway Sweepstakes-Bonus Entry, P.O. Box 7748, Melville, NY 11775- 7748 USA. Limit one (1) mail-in Bonus Entry per envelope. Each mail-in Bonus Entry is equivalent to four (4) Entries. All mail-in Bonus Entries must be complete to be eligible. All mail-in Bonus Entries must be postmarked by September 18, 2026, and received by September 25, 2026, to be eligible for the Grand, First and Second Prize drawing. To be eligible to win a Mid-Way Prize, Bonus Entries must be postmarked by August 28, 2026 and received by September 4, 2026.
- 3) FedEx Rewards (U.S. Residents Only): Once registered, Participants who reside in the U.S. and are enrolled in the FedEx Rewards program will automatically earn four (4) Bonus Entries into the Sweepstakes. Participants who have a FedEx account but are not enrolled in the FedEx Rewards program can earn four (4) Bonus Entries for enrolling in the FedEx Rewards program at getrewards.fedex.com. Separate terms and conditions apply.
- 4) Canadian Bonus Entries (Canada Residents Only): Since the FedEx Rewards program is not available to Canadian residents, a Canadian resident can earn four (4) Bonus Entries on their first mail-in Bonus Entry as allowed in 2) above [for a total of eight (8) Bonus Entries on the first mail-in Bonus Entry and each additional mail-in Bonus Entry will count as four (4) Bonus Entries] by hand-printing their full name, business name (if applicable), FedEx account number (if they have one) and email address on a 3" x 5" piece of paper and mailing it in a separate hand-addressed, stamped envelope with sufficient postage to be mailed to the U.S. to: The FedExCup Getaway Sweepstakes-Bonus Entry, P.O. Box 7748, Melville, NY 11775- 7748 USA. All mail-in Bonus Entries must be complete to be eligible. All mail-in Bonus Entries must be postmarked by September 18, 2026 and received by September 25, 2026, to be eligible for the Grand, First and Second Prize drawing. To be eligible to win a Mid-Way Prize, Bonus Entries must be postmarked by August 28, 2026 and received by September 4, 2026.

Registration Entries and Bonus Entries will be collectively referred to as (“**Entries**”). Limit two hundred (200) Entries per Participant [one (1) via Registration Entry and one hundred ninety nine (199) via Bonus Entries, regardless of method of Entry or combination of methods of Entry. Mechanically reproduced or automated mail-in Entries are not eligible. In the event of a dispute as to any Registration Entry, shipment Bonus Entry or FedEx Rewards Bonus Entry, the authorized account holder (as determined by the business owner, if applicable) of the FedEx account number used to register for the Sweepstakes will be deemed to be the Participant. The “authorized account holder” is the natural person/business assigned to the FedEx account number by FedEx. A potential winner may be required to show proof of being the authorized account holder of the FedEx account number or proof of being an authorized representative of the business associated with the FedEx account number. Normal internet access and usage charges imposed by your internet service provider will apply. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. 4. Prizes and Approximate Retail Values (“ARV”):

Grand Prizes (2): Winner’s choice of one (1) of the following:

Trip includes round-trip economy class air transportation, four (4) nights' hotel accommodations (based on double occupancy), SUV car rental for the duration of the trip, two (2) Hospitality Passes, USD \$1,000 spending money (awarded as a check for winner only), Exclusive behind the scenes tour of the Callaway Headquarters in Carlsbad, CA. Tour includes a walkthrough of Callaway's Research & Development center to showcase the technology behind Callaway's product innovation. The experience will also include a custom full-bag fitting at the Ely Callaway Performance Center, with your club order shipped at a later date based on the results, at no charge and winner's choice of (a) one (1) round of golf at a Sponsor specified golf course; (b) one (1) spa service at a Sponsor specified spa; or (c) one (1) other comparable experience (based on winner's preference and availability). Travel must take place in January 2027. The ARV of Option 2 is USD \$15,350.

Option 3: A 6-day/5-night trip for winner and one (1) travel companion (18 or older) to the 2027 Genesis Scottish Open in Scotland. Trip includes round-trip economy class air transportation, five (5) nights' hotel accommodations (based on double occupancy), car rental for the duration of the trip, Green on 18 tickets for two (2) days during the Genesis Scottish Open (inclusive of select food and beverages), access to private greenside terrace, USD \$1,000 spending money (awarded as a check for winner only), and winner's choice of (a) two (2) rounds of golf at a Sponsor specified golf club; or (b) a private tour of Glasgow and one (1) other excursion (based on winner's preference and availability). Travel must take place in July 2027. The ARV of Option 3 is USD \$15,250.

Option 4: A 5-day/4-night trip for winner and one (1) travel companion (18 or older) to 2027 THE PLAYERS Championship in Ponte Vedra Beach, FL, USA. Trip includes round-trip economy class air transportation, four (4) nights' hotel accommodations (based on double occupancy), SUV car rental for the duration of the trip, Hospitality Passes for two (2) days during the Championship (inclusive of select food and beverages), USD \$1,000 spending money (awarded as a check for winner only), and winner's choice of (a) two (2) rounds of golf at a Sponsor specified golf club; (b) two (2) spa treatments; or (c) two (2) other comparable experiences (based on winner's preference and availability). Travel must take place in March 2027. The ARV of Option 4 is USD \$13,200.

First Prize (1): USD \$5,000, awarded as a check.

Second Prize (1): USD \$2,500, awarded as a check.

Mid-Way Prizes (2): A \$500 VISA gift card.

Limit one (1) prize per Participant.

5. **Drawing:** The Mid-Way Prize winners will be selected in a random drawing on or about September 14, 2026 from among all eligible Entries received during the Mid-Way Prize Period. An entrant may win only one (1) Mid-Way Prize and is not eligible to win both Mid-Way Prizes. Grand, First and Second Prize winners will be selected in a random drawing at the conclusion of the Sweepstakes, on or about October 6, 2026, from among all eligible Entries received/postmarked during the Sweepstakes Period. Winning a Mid-Way Prize does not affect an entrant's eligibility to win a Grand Prize, First Prize, or Second Prize. Drawing will be conducted by the Administrator (at their office in Melville, NY, USA), an independent judging organization whose decisions are final on all matters relating to this Sweepstakes. Odds of winning a prize depend upon the total number of eligible Entries received/postmarked for each drawing during the Sweepstakes Period.
6. **General Rules:** Sponsor reserves the right to substitute a prize of equal or greater value if any advertised prize (or portion of prize) is unavailable for any reason. No substitution or transfer of prize by Participant/winner is permitted, other than as described above. Winners will not receive difference between actual and approximate retail value. Taxes, if applicable, related to prizes are the responsibility of the individual winners/winning businesses. Potential Mid-Way Prize winners will be notified via email to provide their mailing address/confirm their eligibility and must reply within seven (7) days of attempted notification. Once verified, prizes will be sent to winners within six (6) – eight (8) weeks of winner confirmation. Return of prize notification or prize as undeliverable will result in disqualification and alternate selection. Sponsor assumes no responsibility for undeliverable emails resulting from any form of active or passive filtering by email service providers. Potential Grand, First and Second Prize winners will be required to execute and return, via email or prepaid FedEx overnight shipment, a declaration of eligibility and liability/publicity release (where legal) ("Declaration Package") within seven (7) days of attempted notification, or the prize may be forfeited and an alternate winner will be selected. By selecting the option to receive promotional emails from Sponsor, Participant agrees to receive future emails from any FedEx operating company. Canadian Participants' information will be transferred to the U.S.
