

POWER OF ATTORNEY
Indirect representation in customs proceedings

(hereinafter the "Client")

hereby authorizes, in accordance with Article 18 and following of Regulation (EU) No. 952/2013 of the European Parliament and of the Council of 9 October 2013 laying down the Union Customs Code, **FedEx Express Slovakia s.r.o.**, with its registered office at Pri starom letisku 14, Bratislava 36 830 06, Slovak Republic, Identification No. 31 351 603, registered in the Commercial Register maintained by the Municipal Court Bratislava III, Section Sro, File No. 5165/B (hereinafter "FedEx" or "representative"), to:

1. represent the Client within the customs proceedings;
2. act in its own name and on Client's behalf (indirect representation) in dealings with the customs authorities and to perform the acts and formalities laid down by customs legislation;
3. represent the Client in all necessary tax and fee proceedings at the relevant authorities, including customs and tax authorities, in the Slovak Republic;
4. receive and deliver any notifications and other documents and communications and review the tax and customs files;
5. conclude, sign or execute in Client's name any deed, agreement or document related to the purpose of this Power of Attorney;
6. otherwise represent the Client and take any other substantive or procedural legal actions which it may, in its sole discretion, deem necessary within the representation.

FedEx shall be authorized to delegate the above mentioned competencies to its employees who will act as its employees.

The Client further agrees to pay FedEx all fees, taxes and duties assessed by the applicable customs or finance and tax authority within 7 days of the date of the corresponding FedEx invoice. The Client agrees to indemnify FedEx for all damages and costs, including delay payment interests, penalties and other sanctions or charges paid by FedEx in connection with the performance of this agreement and the obligations under the Power of Attorney. The Client agrees to provide FedEx without undue delay, upon request, with all assistance, documents and authorisations required for customs and tax procedures and agrees to indemnify FedEx for any and all damages (including penalties paid) and any non-pecuniary loss in the event of a breach of this obligation. FedEx shall be entitled, in particular in the case of new clients, to request the Client to pay a deposit for the customs liability equal to 30 % of the value of the goods declared for customs purposes.

The Client represents and guarantees compliance with all applicable laws, rules and regulations related to the transportation, import and subsequent EU market access of the goods to be carried by FedEx, including but not limited to Regulation (EU) 2023/956 of the European Parliament and of the Council of 10 May 2023 establishing a carbon border adjustment mechanism (hereinafter the "CBAM Regulation"). Specifically, if and when importing goods under the scope of the CBAM Regulation originating in a third country into the customs territory of the European Union, the Client acknowledges that FedEx will not carry out the reporting on the Client's behalf and considers itself informed in the sense of art. 8.3 of the Commission Implementing Regulation (EU) 2023/1773 of 17 August 2023 laying down the rules for the application of Regulation (EU) 2023/956 of the European Parliament and of the Council as regards reporting obligations for the purposes of the carbon border adjustment mechanism during the transitional period (the CBAM Implementing Regulation). Therefore, the Client will comply itself with all obligations resulting from CBAM, including but not limited to reporting under article 35 of the CBAM Regulation.

By signing this Power of Attorney, the Client gives its consent to send the invoices electronically (the authenticity of the invoice will be secured by a digital signature). If the Client wishes to receive invoices in a paper form, the Client shall fill the contact form at <https://www.fedex.com/en-sk/customer-support/contact.html>, where they choose 'Invoice Inquiries & Payments' as a subject.

This Power of Attorney shall apply in cases when the representative provides its services within TNT group as well as in cases if the representative acts as an authorized representative of Federal Express Corporation, its subsidiaries and affiliates providing FedEx Express services.

By signing this Power of Attorney, the Client acknowledges that it was duly acquainted with the representative's current price list of the customs services while performing TNT services as well as with the price list of the FedEx

Express services and the Client agrees therewith (or its applicable part if there is a single price list and only TNT services or FedEx Express services are provided to the Client and the prices for these services differ). The current price list of the representative is available at fedex.com/sk, whereas any current price list may be subject to additional amendments without any need for the further adjustments or amendments to this Power of Attorney, to which the Client expressly agrees, whereas if the Client is the consumer, its right as the consumer to revoke this Power of Attorney is not affected.

This Power of Attorney is granted for an indefinite period of time, until it is withdrawn either by the Client or the representative.

This Power of Attorney is construed and governed by the laws of the Slovak Republic.
