You can customize your FedEx core services shipments to your needs (or the needs of your recipients) with value added services from FedEx Express. The following are descriptions of the fees applicable to value added services.

FedEx® Delivery Signature Options	<p>The following delivery signature options⁽⁵⁾ may be chosen at the time of booking your shipment:</p> <ol style="list-style-type: none"> 1. No Signature Required: FedEx will attempt to obtain a signature at the delivery address. If no one is available to sign, FedEx will deliver the package in a safe place without obtaining signature. 2. Indirect Signature Required: FedEx will obtain a signature from someone at the delivery address, from a neighbor or from a building manager. If no one is available to sign, FedEx will attempt to redeliver the package. 3. Direct Signature Required: FedEx will obtain a signature from someone at the delivery address only. Adult Signature Required: FedEx will obtain a signature from any person of legal age at the delivery address, subject to sighting of a valid ID. Additional Handling Surcharge	Package Services A surcharge applies to a shipment containing any package that: (Dimension) 1) measures greater than 121 centimeters along its longest side. 2) measures greater than 76 centimeters along its second-longest side; or, 3) measures greater than 266 centimeters in length and girth (L+2W+2H). Package shape and dimensions may change during transit, which can affect the package's surcharge eligibility. If the dimensions change during transit, FedEx may make appropriate adjustments to the shipment charges at any time.	€45/shipment
	Freight Services A surcharge applies to a shipment containing any freight handling unit that measures greater than 157 centimeters along its longest side. We reserve the right to assess additional handling charges for freight and any freight handling unit that requires special handling during transit.	€55/shipment
Additional Handling Surcharge – Non-stackable ⁽⁶⁾	A surcharge applies to any FedEx International Priority Freight and FedEx International Economy Freight shipment containing at least one piece, skid or pallet that is non-stackable. Non-stackable means that a piece, skid, or pallet cannot be stacked vertically in a safe and secure manner. This surcharge applies once per shipment, even if multiple pieces identified as non-stackable are bundled in a shipment.	€154/shipment
Address Correction	If a recipient's address on an Air Bill, Air Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment. For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment. If we are unable to complete delivery under these circumstances, we will not be liable for failing to meet our delivery commitment.	€10/shipment
