

## **FedEx and UEFA Champions League competition - Terms and Conditions & Privacy Policy**

---

### **ARTICLE 1 – ORGANIZER OF THE SWEEPSTAKES**

This sweepstakes, titled “*UEFA Champions League Sweepstakes*” (the “Sweepstakes”), is organized by FedEx Express Austria GmbH, Cargo Nord, Obj. 3, 1300 Wien-Flughafen („FedEx“) and its subsidiaries and affiliated companies (“FedEx”) in accordance with these terms and conditions (the “Terms and Conditions”).

### **ARTICLE 2 – SCOPE / TERRITORY**

Participation in the Sweepstakes is limited to Austria (the “Country”).

---

### **ARTICLE 3 – PARTICIPATION PERIOD**

Participation in the Sweepstakes is possible from **09:00 on 17 March 2026** until **24:00 on 17 April 2026** local time in the Country.

### **ARTICLE 4 – PARTICIPANTS**

#### **4.1 Eligible Participants**

Participation is open to persons who, at the time of entry:

- (i) are of legal age in the respective Country, and
- (ii) have their residence and/or headquarters in the respective Country (the “Participants”).

#### **4.2 Non-eligible Participants**

Employees and/or independent subcontractors of FedEx Corporation or any of its affiliated companies, as well as their representatives, executives, and officials of public institutions, governmental entities, legal entities under public law, political parties, or international organizations, and persons seeking political office, are not eligible for participation in the Sweepstakes (the “Non-Eligible Participants”).

#### **6.1 Participation**

To enter the Sweepstakes, Participants must complete an online form and answer a few questions.

Answering the questions constitutes confirmation and registration for the draw.

- The questions will be the same for all Participants.
- Each Participant may enter only once per person/email address.

- Participation is free of charge.
- A FedEx or TNT customer account or VAT number is required.

### **6.2 Registration / Consent**

Eligible Participants must agree to these Terms and Conditions and the country-specific FedEx Privacy Policy and provide the required Registration Information:

- Title, First Name, Last Name
- Phone Number, Email Address
- Company Name
- Company Address, Postal Code, City
- Customer Number (if applicable) or VAT number
- Answer to the sweepstakes question “How many stars are in the UEFA Champions League logo?”
- Optional: Additional questions for shipping interests, e.g., destinations, type of shipments and type of customers

#### **Consent for Marketing Purposes:**

By registering, participants agree that FedEx may contact them via email or other communication channels with marketing campaigns, offers, and information about FedEx services. This consent can be revoked at any time, free of charge, via this opt-out [link](#).

Participants are responsible for the accuracy of their information. FedEx reserves the right to verify the data, including by requesting proof of identity.

### **6.3 Exclusion**

Participants who are not eligible, fail to provide the required information, provide false or incomplete information, or submit forged documents will be automatically excluded from the Sweepstakes. No claim to any prize will exist.

## **ARTICLE 7 – DATA PRIVACY**

The information provided constitutes personal data and will be processed by FedEx exclusively for the purposes of administering the Sweepstakes.

- The data may be used by FedEx to contact participants regarding the Sweepstakes.

With explicit consent, the data may also be used for marketing purposes, such as personalized offers, newsletters, or information about FedEx products and promotions. Participants may revoke this consent at any time via this opt-out [link](#).

## **ARTICLE 8 – PRIZES**

### **8.1 Category A – Main Prize**

- 2 overnight stays for 2 persons, including breakfast on 30.05 and 31.05.26
- Transfers Hotel ↔ Stadium:
  - Friday, 29.05.2026: Airport → Hotel
  - Saturday, 30.05.2026: Hotel → Stadium → Hotel
  - Sunday, 31.05.2026: Hotel → Airport
- Total value: € 4,010.00 (incl. VAT)
- Note: Arrival/departure from the winner's residence and personal expenses are not included.

## **8.2 Category B – Secondary Prizes**

- **10** UEFA Champions League adidas replica match balls
- Value per football: € 60.00
- Total value: € 600.00
- Prizes are non-transferable and cannot be redeemed for cash.

## **ARTICLE 9 – PRIZE DRAW / AWARDING OF PRIZES**

- The Category A winner will be selected from all Participants that answered the Sweepstake question correctly by random draw no later than **23 April 2026** with legal support.
- **10** winners will each receive a Category B prize.
- 5 substitute winners will be determined to ensure reallocation if a prize is not claimed.
- Winners must meet the acceptance deadlines; otherwise, the prize will be awarded to the next substitute winner.

## **ARTICLE 10 – LIABILITY LIMITATION**

- FedEx may change, cancel, or postpone the Sweepstakes at any time.
- FedEx is not liable for failures, delays, or cancellations caused by third parties, internet issues, incorrect email addresses, or incomplete participant information.
- FedEx is not liable for any losses or damages related to participation or prize use.

## **ARTICLE 12 – APPLICABLE LAW AND JURISDICTION**

- The laws of Austria apply.
  - The courts of Austria have exclusive jurisdiction.
