

## **FedEx and UEFA Champions League competition - Terms and Conditions & Privacy Policy**

### **COMPETITION ORGANIZER**

This Competition called the “**FedEx and UEFA Champions League competition**” (“**Competition**”) is being run by FedEx Express BE B.V., Bedrijvenzone Machelen Cargo 711 1830 Machelen, Belgium registered with the registration number BE 406.383.379 and its affiliates (“**FedEx**”) in accordance with these terms and conditions (“**Terms and Conditions**”).

### **TERRITORY**

Participation in the Competition is limited to the country of Belgium (individually “**Country**”).

### **TERM**

Entry into the Competition will be open from 09:00am CET on 17 March 2026, and close at 11:59pm CET on 17 April 2026 (“**Competition Period**”).

### **ELIGIBLE PARTICIPANTS**

Participation in the Competition is reserved solely for registered legal entities or other individual entrepreneurs registered as business entities in Country.

To be eligible to participate, entrants must, at the time of entry:

- (i) be of legal age in the relevant country, and
- (ii) reside and/or be domiciled in the relevant country.

(“the **Participants**”).

### **NON-ELIGIBLE PARTICIPANTS**

Competition is not intended for individuals in the role of a consumer.

Employees and/or independent subcontractors of FedEx Corporation or any of its affiliates are not eligible for participation in the Competition (“**Non-Eligible Participants**”).

### **RULES OF PARTICIPATION**

#### **Participation:**

To take part in the Competition, Participants must complete an online form and a questionnaire. Submitting the questionnaire answers constitutes confirmation and registration for participation in the Competition.

The questions will be the same for all Participants.

Each Participant may enter only once per person/email address.

Participation in the Competition is free of charge.

A FedEx or TNT customer account or VAT number is required.

#### **Registration:**

To complete their registration, the Participant must answer a series of questions and provide the following information (the “**Registration Information**”):

- (ii) Design a one-line slogan that combines your brand and the Champions League spirit in Budapest.
- (iii) Are you currently shipping goods, or planning to start soon?
- (iv) Which destinations do you currently ship to, or expect to ship to soon?
- (v) What is the nature of your current or upcoming shipments?
- (vi) Who are your current or prospective customers?

- FedEx or TNT customer account number or VAT number

Participants are responsible for the Registration Information they provide and for ensuring its accuracy. FedEx will not be in any way liable for any incorrect and/or untruthful Registration Information provided by Participants. In any case, FedEx reserves the right to verify the truthfulness of any information provided, which may include requiring proof of identification.

**Exclusion:** Non-Eligible Participants, or those who fail to send the requested information, send the requested documentation late, incomplete, falsified, tampered with or not in compliance with what is specified in these Terms and Conditions, will automatically be excluded from the Competition and will not qualify for any prize. FedEx reserves the right to exclude any Participant who does not comply with the rules set out in these Terms and Conditions.

**DATA PRIVACY**

The Participant will be required to select their preferences regarding data processing for marketing purposes.

The Registration Information requested is mandatory in order to participate in the Competition. This information constitutes **Personal Data**, which is collected and processed by FedEx for the purposes of managing the Competition. The information provided by Participants when registering may be used by the sales team to contact them regarding the Competition.

By submitting the application, Participants consent to be contacted by a FedEx representative in respect of the Competition.

The Personal Data may also be used for direct marketing purposes, specifically via electronic communications. During registration, the Participant will be required to:

- (i) indicate whether they agree to receive such communications, and
- (ii) specify their preferences regarding the processing of their data for direct marketing purposes.

## PRIZES

The following prizes (“Prizes”) are available to be won:

### Grand Prize

One (1) package consisting of **two Category 1 tickets** to the **2026 UEFA Champions League Final**, to be held on **30 May 2026** at the **Puskás Aréna in Budapest, Hungary**, including **2 nights’ accommodation** and **hotel/stadium transfers**.

The total value of this prize is **EUR 4,010.00**, all taxes included.

The Grand Prize includes accommodation and transfers\* as described below:

- Arrival on Friday 29 May: from airport to the hotel
- Two (2) nights’ accommodation (Friday 29 May and Saturday 30 May 2026) for two people at a hotel in Budapest. The name and address of the hotel will be communicated to the winner by FedEx. Accommodation will be either a twin room or a double room, depending on availability.
- Breakfast for two on Saturday 30 May and Sunday 31 May 2026
- Saturday 30 May: from hotel to stadium, and from stadium back to hotel
- Sunday 31 May: from hotel to airport

\* Transfers will only be included for BUD airport in Budapest. If arriving at another airport or train station, the winner and their guest must organise and pay for their own transfer to the hotel (round-trip transfers between the hotel and the stadium on match day will still be covered).

**The Grand Prize does not include travel to and from Hungary**. It is the responsibility of the winner and his/her guest to make their own travel and transport arrangements to and from their origin/city of residence to Budapest, Hungary to redeem the prize, ensuring compliance with all travel requirements, including but not limited to passport, visa, and insurance requirements.

For the avoidance of doubt, travel insurance, tips, additional meals/drinks, additional hotel services (including but not limited to minibar consumption, telephone calls, beverages, and movie rentals), as well as other personal expenses, are not included in the Grand Prize.

To qualify for the Grand Prize, participants and their guests must be 18 years or over at the time of participation in the competition.

### Runner up Prizes

Ten (10) Runner Up prizes will be awarded. Each Runner Up will receive one (1) UEFA Champions League adidas replica match ball.

The value of this ball is approximately **EUR 60.00**, including VAT.

Prizes may not be exchanged for cash and are non-transferable.

## ALLOCATION OF PRIZES

### Grand Prize and Runner up prizes

#### Eligible Participants:

Participants eligible to win the Grand Prize or a Runner up prize will be the **11 (eleven) Participants** who answered the competition question correctly and are selected by a jury no

later than **23 April 2026** (the “Winners”).

Among the 11 Winners:

- The first Winner selected will receive the **Grand Prize**.
- The remaining 10 Winners selected will each receive a **Runner up prize**.

Winners may only receive **one (1) prize**, either the Grand Prize or a Runner Up prize.

Winners of one of these prizes are therefore excluded from Reallocation.

### **Winner’s selection**

A panel of judges will be appointed to select, in order and according to its sole discretion, the eleven (11) most creative answers and, among them, the one (1) winner for the Grand Prize and ten (10) winners of the Runner-Up Prize. The jury’s decision is final and is not subject to appeals or complaints.

The judging panel will select an additional three (3) Substitute winners, in the event that the Grand Prize Winner cannot, for any reason, receive the prize, in accordance with the Reallocation procedure.

The judging panel will consist of three (3) representatives from FedEx, selected from different internal functions within the business.

If the Grand Prize Winner

- a. is unavailable, or
- b. fails to provide, within the deadlines, the required documents referred to in the article on Rules of Participation, or
- c. provides false information, or
- d. does not comply with these Terms and Conditions or fails identity verification carried out by FedEx, or
- e. does not accept the Grand Prize by **29 April 2026 at 23.59 CET**,

the “Reallocation” procedure will apply, and the prize will be awarded to the first Substitute Winner. If the first Substitute Winner does not accept the prize within **3 days** of notification, the prize will be awarded to the second Substitute Winner, and then to the third Substitute Winner under the same conditions. If the third Substitute Winner does not accept the prize, it will be deemed forfeited and will not be reallocated.

### **Compliance with the Terms and Conditions**

If a Participant or Winner fails to comply with any provision of these Terms and Conditions, they will not be entitled to any prize.

### **NOTIFICATION TO WINNERS**

The Grand Prize winner of the Competition will be informed on or before **24 April 2026**, and Runner Up winners will be informed on or before **8 May 2026**.

If the information provided by the Participant is incomplete and/or does not allow FedEx to notify them of their prize, they will lose their status as Winner and may not make any claim

Winners will be sent a notification by email to the address provided at registration. After verification of the accuracy of the information provided by the Winner, the prize will be confirmed and instructions for receiving it will be sent by email.

Runner Up Prizes will be shipped to Winners at the address provided within **60 days** following the announcement of the results. FedEx will cover shipping costs.

Participants who are not Winners will not be notified by post, email, or any other means.

## **LIMITATION OF LIABILITY**

FedEx takes no responsibility for Participant registrations that are incomplete due to reasons outside its control.

Regarding the Notification to winners, FedEx shall not be held liable in the following cases:

- Winner's or Participant's mailbox being full;
- deactivation of the Winner's or Participant's mailbox;
- non-existent, incorrect, or incomplete email address provided;
- incorrect and/or inaccurate information provided by a Winner or Participant, including but not limited to phone numbers, email addresses, postal addresses, or personal information;
- Internet, computer, postal operator, or Internet service provider delays or malfunctions.

All Participants and Winners are solely responsible for managing their e-mail inbox, including but not limited to:

- checking their emails and complying with the instructions for redeeming the prize
- taking the necessary security measures to prevent anyone else from having unauthorized access to their email account.

FedEx shall not be liable for any loss, injury, claim, liability, or damage of any kind resulting in any way from the attendance or non-attendance of the UEFA Champions League final 2026 match for the winners.

FedEx shall not be liable for any cancellation or postponement, at UEFA's initiative, of the UEFA Champions League final 2026.

In case the prize or the value thereof is considered by the local applicable legislation as a remuneration the participant is fully responsible to report the appropriate related taxation and any other financial obligation fulfillment thereof.

Regarding the prizes:

- No liability can be attributed to FedEx in the event of improper use by a Winner or Participant of the aforementioned prizes or use by people who are unsuitable due to age or physical/mental conditions.
- in the event of problems with the product such as faults or malfunctioning of the prizes themselves, all guarantees and relative limitations in reference to the guarantees attributable to the supplier apply.
