# FedEx and UEFA Champions League competition - Terms and Conditions & Privacy Policy

## **COMPETITION ORGANIZER**

This Competition called the "FedEx and UEFA Champions League competition" ("Competition") is being run by FedEx Express Danmark ApS, Jernholmen 28-32, 2650 Hvidovre, Denmark registered with the registration number DK 76 56 25 12 and its affiliates ("FedEx") in accordance with these terms and conditions ("Terms and Conditions").

### **TERRITORY**

Participation in the Competition is limited to the country of Denmark (individually "Country").

#### **TFRM**

Entry into the Competition will be open from 09:00am CET on 11 February 2025, and close at 12:00 CET on 18 April 2025 ("Competition Period").

## **APPLICABLE LAW & JURISDICTION**

This Competition is subject to the laws of Denmark and the exclusive jurisdiction of the competent courts in Copenhagen, Denmark, for all purposes relating to this Competition.

# **ELIGIBLE PARTICIPANTS**

Participation in the Competition is reserved solely for registered legal entities or other individual entrepreneurs registered as business entities in Country who are FedEx customers or become FedEx customers during the Competition Period ("Eligible Participants").

### **NON-ELIGIBLE PARTICIPANTS**

Competition is not intended for individuals in the role of a consumer. Employees and/or independent subcontractors of FedEx Corporation or any of its affiliates are not eligible for participation in the Competition.

# **ELIGIBLE SHIPMENTS**

To participate in the Competition, Eligible Participants must import and/or export shipments within European countries (see below country list), using one of the below stated FedEx services and be invoiced in an eligible Country during the Competition Period (the date of shipment pick-up is determining). ("Eligible Shipment")

**Eligible Shipment services:** Only FedEx Economy (FedEx International Economy®, FedEx International Economy® Freight, FedEx® Regional Economy, FedEx® Regional Economy Freight) or TNT Economy (Economy Express, Economy Freight). Competition does not apply to domestic shipments shipped within the Country.

Eligible European countries: <u>EU countries</u>: Austria, Belgium, Bulgaria, Croatia, Republic of Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain and Sweden. <u>Non-EU countries</u>: Albania, Andorra, Armenia, Azerbaijan, Bosnia and Herzegovina, Georgia, Iceland, Kosovo, Liechtenstein, Moldova, Monaco, Montenegro, North Macedonia, Norway, San Marino, Serbia, Switzerland, Turkey, Ukraine, United Kingdom, Vatican City.

Every Eligible Shipment is identified by its FedEx or TNT shipping number.

### **RULES OF PARTICIPATION**

Competition entry is open from 09:00am CET on 11 February 2025 and closes at 12:00 CET on 18 April 2025.

Eligible Participants may enter the Competition by filling out the online application form via <a href="fedex.com/konkurrence">fedex.com/konkurrence</a> with their respective FedEx and/or TNT account number.

To complete the registration, the Eligible Participant must submit all the requested details on the Competition application form, after having read and accepted these Terms and Conditions and Privacy Policy.

After submitting the application, the company's first Eligible Shipment, shipped via the registered FedEx or TNT account, will qualify the Eligible Participant to participate in the Competition. The winner will be the one who has answered the first question correctly and is judged to have given the most original and creative answer to the second question, as also further stated in the section "Allocation of prizes".

By submitting the application, Eligible Participants consent to be contacted by a FedEx representative in respect of the Competition.

Participants are responsible for the information provided during registration and for ensuring its accuracy. FedEx will not be in any way liable for any incorrect and/or untruthful information provided by participants. In any case, FedEx reserves the right to verify the truthfulness of any information provided, which may include requiring proof of identification.

FedEx will not be liable for any incomplete, illegible and/or falsified documentation sent by participants.

## **PRIZES**

The following prizes ("Prizes") are available to be won:

# **GRAND PRIZE**

- a) One (1) package to the UEFA Champions League final 2025 on 31 May 2025. Total value of each package is approximately 29,000 DKK, excluding VAT. Each package includes the following items:
  - Two (2) General Admission Category 1 tickets to the UEFA Champions League final 2025 at Munich Football Arena in Munich, Germany on 31 May 2025.
  - Two (2) nights' accommodation (Friday 30 May and Saturday 31 May 2025) for two people at a hotel in Munich. The name and address of the hotel will be communicated to the winner by FedEx. Accommodation will be either a twin room or a double room, depending on availability.
  - Breakfast for two on Saturday 31 May and Sunday 1 June 2025.
  - Return transfers\*, upon arrival 30 May and return 1 June 2025, from selected airports and/or train stations to the hotel. Details will be provided by FedEx to the winner. Both guests must arrive at the same time and location. FedEx will inform the winner of the required details.
  - Return transfers from the hotel to Munich Football Arena on 31 May 2025.

<sup>\*</sup> Return transportation is only included for selected Munich airports and/or train stations, which will be communicated to the winner no later than one month prior to the event. Upon arrival at another airport or train station, the winner and their guest must arrange and pay for their own transportation to the hotel.

The Grand Prize does not include travel to and from Germany from the winner's country/city of residence nor for winners in Germany to and from Munich. It is the responsibility of the winner and his/her guest to make their own travel and transport arrangements to and from their origin/city of residence to Munich, Germany to redeem the prize.

It is also the responsibility of the winner and his/her guest to ensure they meet all travel requirements, including but not limited to passport, visa and insurance.

# **RUNNER UP PRIZES**

Ten (10) Runner Up prizes will be awarded. Each Runner Up will receive one (1) UEFA Champions League adidas replica match ball. The value of this ball is approximately 450 DKK, including VAT.

## **ALLOCATION OF PRIZES**

A panel of judges will be appointed to select, according to its sole discretion, the eleven (11) best answers and, among them, the one (1) winner for the Grand Prize and ten (10) winners of the Runner-Up Prize. The decision of the panel is final and cannot be subject to appeal or complaint.

The judging panel will consist of three (3) representatives from FedEx, selected from different internal functions within the business.

The judging panel will select an additional five (5) reserve winners, who will be selected (in order ranked by the panel) for a Runner Up prize in the event of any of the eleven winners first selected are not eligible for the prize, or do not respond to the prize communications within the timeframe stated.

The winner selection will take place on or before **Monday 28 April 2025**.

Should a winner or reserve fail to comply with any of these Terms and Conditions or not meet all the obligations related to the selected Eligible Shipments in-line with FedEx or TNT Conditions of Carriage, they will not qualify for a prize.

# **NOTIFICATION TO WINNERS**

The Grand Prize winner of the Competition will be informed on or before April 28, 2025, and Runner Up winners will be informed on or before May 5, 2025.

Winners will be sent notification by e-mail to the address provided during registration. Winners must reply within 3 (three) days from receipt of the e-mail to accept or decline their prize, to the following address marketing.nbnl@fedex.com.

Once the accuracy of the information provided by the winner has been verified, the prize will be confirmed and instructions for receiving it will be sent by e-mail.

If the winner does not reply to the subjected email as stated here or the winner is unable to accept the Prize when delivered, their right to the prize will automatically lapse. In such case FedEx reserves the right to select additional winner(s).
