

UEFA Champions League Referee Mascot Prize Draw (“Prize Draw) – Terms & Conditions

1. The Prize Draw is open to all residents in Germany, Portugal, Spain and the United Kingdom aged 18 years or over except employees of the Promoters or any other FedEx company, their families, agents or any third party directly associated with the administration of the Prize Draw (**‘Qualifying Individuals’**). Only one entry per Qualifying Individual is permitted.
2. The Prize Draw is free to enter and no purchase is necessary.
3. All entries into the Prize Draw must be submitted via the FedEx Referee Mascots Entry Form (<https://www.fedex.com/en-gb/sponsorship/ucl/referee-mascots.html>) and must contain all the information required.
4. The opening date for entries into the Prize Draw is 1900 CET on 1st December 2025. The closing date of the Prize Draw is 1159 CET on 15th December 2025. Entries received after this time or which do not contain all required information will not be counted.
5. To enter the Prize Draw, Qualifying Individuals must accept these terms and conditions, provide their details and confirm that they have a child that meets the UEFA Mascot Requirements set out below and that is a direct relative of the Qualifying Individual (for example a son, daughter, niece, nephew etc) or for whom the Qualifying Individual is the legal guardian (**‘Nominated Child’**).
6. The Promoter accepts no responsibility for entries not successfully completed due to a technical fault of any kind
7. The **‘Prize’**: there are six of the following FedEx Referee Mascot prize packages to be won (for six separate winning entries) which includes:
 - One qualifying child to act as an official UEFA Champions League FedEx Referee Mascot and participate in the UEFA Champions League match on January 28th, 2026 at 2100 hours between EITHER Eintracht Frankfurt and Tottenham Hotspur in Frankfurt at the Deutsch Bank Park OR Benfica and Real Madrid in Lisbon at the Estadio da Luz as part of relevant pre-match ceremony and lead the referees, with the teams following, onto the pitch.

Two Category 2 tickets to watch one of the above UEFA Champions League matches - one ticket for the Winning Child and one tickets for the Winning Adult.

- Return flight travel from your home country to the country the relevant game is played or if in-country, return train travel, (booked by a FedEx appointed travel agency)
- Transfers: Airport/railways station transfers to and from the hotel accommodation plus transfers to and from the stadium for the game.
- **Exclusions:** Travel expenses within home country (to the airport/railway station, parking etc.) are not included in the prize and is the responsibility of the winners. Any other meals/expenses not specified are also not included in the Prize.

- One UEFA Champions League FedEx referee mascot uniform including a t-shirt, shorts and socks (**'Referee Mascot Uniform'**).
 - One night hotel accommodation on January 28, 2026 in a pre-selected hotel (1 room for both the Adult and Winning Child), including breakfast on 29th January, 2026 only.
8. The Promoter is not responsible for any other expenses of any other kind except those included in or part of the Prize as stated above. For the avoidance of doubt this means that the Promoter is not responsible for the cost/expense of the winners travel to the event (save as set out above).
9. The Promoter will not accept any responsibility for accommodation or transport being unavailable, withdrawn or amended. In the event of this the Promoter will endeavour to find a suitable alternative.
10. A Qualifying Individual that enters the Prize Draw and wins will be referred to as **'Winning Adult'**. The Winning Adult will upon request provide details to the Promoter of the Nominated Child who will be referred to as **'Winning Child'**.
11. The following are the requirements stipulated by UEFA for a child to qualify as a referee mascot **'UEFA Mascot Requirements'**:
- The Winning Child must be aged between 6 and 9 years old at the time of the UEFA Champions League matches referenced above.
 - The Winning Child must be between 1.05 -1.35 meters in height at the time of the match to ensure they can fit the standard-sized official UEFA Referee Mascot uniform.
 - The Winning Adult and Winning Child must agree to strictly follow the instructions given by the UEFA representative during the Prize experience which acting as a UEFA Champions League FedEx referee mascot.
12. UEFA will make the final determination on whether any Winning Child meets the UEFA Mascot Requirements. In the event that any Winning Child does not meet the UEFA Mascot Requirements the Promoter may select another winner in accordance with the process described below.
13. The following are additional conditions of entry into the Prize Draw:
- the Winning Adult agrees to provide details and any supporting information of the Nominated Child when requested.
 - the Winning Adult agrees to complete a parental/legal guardian consent form in advance of acting as a UEFA Champions League FedEx referee mascot and no later than 4 (four) days of receipt of the form.
 - the Winning Child must wear the Referee Mascot Uniform when acting as a UEFA Champions League FedEx referee mascot.
 - the Winning Adult and Winning Child agree that the Winning Child will wear their own dark coloured trainers or football boots with no visible branding (these will not

be provided by the Promotor or UEFA). Any visible branding must be taped over with similar dark coloured masking tape.

- The Winning Adult and Winning Child agree to make themselves available and be present on the day of the UEFA Champions League match as required and in accordance with the schedule for the day that will be distributed to the Winning Adult in advance of the match and will meet at such meeting point(s) as advised.
- The Winning Adult will be responsible for supervising the Winning Child at all times save for when acting as the UEFA Champions League FedEx referee mascot as part of the pre-match ceremony and rehearsals.

14. Prize winners will be chosen by a random draw on December 17th 2025 ('**Draw Date**').

15. Prize winners will be notified by email or telephone (using details provided at entry) before [December 22nd 2025. If a winner does not respond to the relevant Promoter within 7 calendar] days of being notified by the Promoter, then the winner's Prize will be forfeited and the Promoter will be entitled to select another winner in accordance with the process described above.

16. If the Winning Adult and/or Winning Child do not comply with the terms and conditions of the Prize Draw including in particular as set out in paragraph 12 above or the Winning Child is not able to perform their role as a referee mascot the Prize will be forfeited and be withdrawn and the Promoter will have no liability for such forfeiture and withdrawal.

17. The UEFA Champions League matches are public events and will be broadcast/displayed on a variety of media (including television, online, photographs etc) and the Winning Adult agrees and acknowledges that images of the Winning Child may be captured by such media which may be displayed on the on such media across Europe or worldwide. The Winning Individual agrees and acknowledges that by completing the parental/legal guardian consent form they are consenting to such images being captured and displayed.

18. UEFA will secure suitable changing rooms and toilet facilities for the Winning Child. The changing facility may be shared with other pre-match ceremony participants.

- The adult should be aware that they will be 'separated' from their child from 60-90mins before kick-off until 10-15 mins after kick-off while the chaperone and VSSM look after the child inside the stadium and changerooms. The only facilities available to the Winning Adult are the public stadium toilets.

19. The Winning Child will leave their belongings in the dressing facilities prior to the rehearsal (if facilities allow, or if safe storage is available). These will be collected by Winning Child immediately after the performance and before moving to their seat in the stadium for the match.

20. The Prize is non-exchangeable, non-transferable and no cash alternative is offered.

21. The Prize and all elements of it are personal to the Winning Adult and Winning Child and the sale, transfer, resale, donation or exchange of any part of the Prize is strictly prohibited (including but not limited to via an online auction or online ticket resale marketplace). The relevant Promoter reserves the right to cancel tickets, travel,

accommodation or make void any and all parts of the Prize if this term or any other term and condition is not complied with.

22. The decision of the Promoter regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.
23. All travel, accommodation and other services provided to the Winning Adult and Winning Child will be provided subject to the terms and conditions of each such provider. The Promoter will not have any liability in relation to this and any dispute arising from travel, accommodation and/or other services must be taken up with such provider.
24. The Promoter will have no liability in the event that the Prize has to be cancelled due to unforeseen circumstances (whether at short notice or otherwise) including but not limited to the cancellation or postponement of the UEFA Champions League football matches referenced as part of the Prize for any reason which could include extreme weather conditions or health concerns. The Promoter will endeavour to notify the Winning Adult as soon as possible should this happen.
25. Attendees acknowledge and agree that they are subject to and will comply with the terms and conditions of the Category 2 tickets for the venues at which the UEFA Champions League football match they will attend is being held (**'Ticket Terms & Conditions'**). The terms and conditions are subject to change from time to time and may include the requirement for ticket holders to present valid photo ID (passport or driving licence) and/or other forms of identification upon entry to the match to ensure that the ticket holder is the same as the person named on their ticket.
26. Failure to comply with any of the Ticket Terms and Conditions may result in refused entry, or the ticket holders being required to leave the match. The venue reserves the right to remove any person or refuse any person entry to the venue regardless of whether they have a valid ticket. If a ticket is declared void or if a ticket holder is refused admission or removed from the match because of a breach of the Ticket Terms and Conditions or breach of the venue terms and conditions, the Promoter will have no liability to replace the Prize or provide any form of refund.
27. Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The Promoter reserves the right to refuse entry, or refuse to award the Prize to anyone in breach of these terms and conditions.
28. The Promoter reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.
29. Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.
30. These terms and conditions and this promotion is governed by the laws of the country in which the relevant Promoter is incorporated. If entrants wish to take court proceedings then they must do so in the courts in the country of the relevant Promoter.

We won't disclose your personal data to third parties except, to other such subsidiaries of FedEx for the purpose of administering the Prize Draw or, in the case of you as the Winning Adult and Winning Child, providing the Prize.
