

## FedEx and UEFA Champions League competition

### Terms and Conditions & Privacy Policy

#### COMPETITION ORGANIZER

This Competition called the “**FedEx and UEFA Champions League competition**” (“**Competition**”) is being run by FedEx Express UK Limited and its affiliates (“**FedEx**”) in accordance with these terms and conditions (“**Terms and Conditions**”).

#### TERRITORY

Participation in the Competition is limited to the country of Republic of Ireland (individually “**Country**”).

#### TERM

Entry into the Competition will be open from 08:00am GMT on 18 March 2024, and close at 11:00 GMT on 19 April 2024 (“**Competition Period**”).

#### ELIGIBLE PARTICIPANTS

Participation in the Competition is reserved solely for registered legal entities or other individual entrepreneurs registered as business entities in Country who are FedEx customers or become FedEx customers during the Competition Period (“**Eligible Participants**”).

#### NON-ELIGIBLE PARTICIPANTS

Competition is not intended for individuals in the role of a consumer. Employees and/or independent subcontractors of FedEx Corporation, or any of its affiliates, are not eligible for participation in the Competition.

#### ELIGIBLE SHIPMENTS

To participate in the Competition, Eligible Participants must import and/or export shipments within European countries (*see below country list*), using one of the below stated FedEx services and be invoiced in an eligible Country during the Competition Period (*the date of shipment pick-up is determining*). (“**Eligible Shipment**”)

**Eligible Shipment services:** FedEx (FedEx International Priority®, FedEx International Priority® Freight, FedEx International Priority® Express and FedEx International First®, FedEx International Economy®, FedEx International Economy® Freight, FedEx® Regional Economy, FedEx® Regional Economy Freight) or TNT (Express, 9:00 Express, 10:00 Express, 12:00 Express, Economy Express, 12:00 Economy Express). Competition does not apply to domestic shipments shipped within the Country.

**Eligible European countries:** EU countries: Austria, Belgium, Bulgaria, Croatia, Republic of Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain and Sweden. Non-EU countries: Albania, Andorra, Armenia, Azerbaijan, Belarus, Bosnia and Herzegovina, Georgia, Iceland, Kosovo, Liechtenstein, Moldova, Monaco, Montenegro, North Macedonia, Norway, Russia, San Marino, Serbia, Switzerland, Turkey, Ukraine, United Kingdom (left the EU on January 31, 2020), Vatican City.

Every Eligible Shipment is identified by its FedEx or TNT shipping number. Multi-piece shipments are considered as one shipment for Competition purposes, irrespective of the number of pieces it consists of. The number of eligible shipments for one registered Eligible Participant is not limited.

## RULES OF PARTICIPATION

Competition entry is open from 08:00am GMT on 18 March 2024 and closes at 11:00 GMT on 19 April 2024.

Eligible Participants, may enter the Competition by filling out the online application form via <https://www.fedex.com/en-ie/sponsorship/ucl/uefa-competition.html> with their respective FedEx and/or TNT account number.

To complete the registration, the Eligible Participant must submit all the requested details on the Competition application form, after having accepted these Terms and Conditions and Privacy Policy.

After submitting the application, all the company's Eligible Shipments, shipped via the registered FedEx and/or TNT account(s), will be entered into the Competition. **The more Eligible Shipments an Eligible Participant makes, the higher their chances of winning a prize will be.**

By submitting the application Eligible Participants consent to be contacted by a FedEx representative in respect of the Competition and in relation to other FedEx services.

Participants are responsible for the information provided during registration and for ensuring its accuracy. FedEx will not be in any way liable for any incorrect and/or untruthful information provided by participants. In any case, FedEx reserves the right to verify the truthfulness of any information provided, which may include requiring a proof of identification.

Non-Eligible Participants, or those who fail to send the requested information, send the requested documentation late, incomplete, falsified, tampered with or not in compliance with what is specified in these Terms and Conditions, will automatically be excluded from the Competition and will not qualify for any prize.

FedEx reserves the right to exclude any participant in breach of the rules in these Terms and Conditions. FedEx will not be liable for any incomplete, illegible and/or falsified documentation sent by participants.

## PRIZES

The following prizes ("Prizes") are available to be won:

### GRAND PRIZE

- a) One (1) package to the UEFA Champions League final 2024 on 1 June 2024. Total value of each package is approximately 2,943.85 EUR, excluding VAT, but this is subject to change. Each package includes the following items:
- Two (2) General Admission Category 1 tickets to the UEFA Champions League final at Wembley Stadium in London, UK on 1 June 2024.
  - Two (2) nights' accommodation (Friday 31 May & Saturday 1 June 2024) for two people at a hotel in London. The name and address of the hotel will be communicated to the winner by FedEx. Accommodation will be either a twin room or a double room, depending on availability.
  - Breakfast for two on Saturday 1 and Sunday 2 June 2024.
  - Return transfers, on arrival 31 May, return 2 June 2024, from selected airports (London Heathrow/LHR and London Gatwick/LGW) and train stations (King's Cross/St Pancras and Waterloo) in London to the hotel. Both guests must arrive at the same time and same location.

- Return transfers from the hotel to Wembley Stadium on 1 June 2024.

**The Grand Prize does not include travel to and from the UK from the winner's country/city of residence nor for winners in the UK travel to and from London.** It is the responsibility of the winner and his/her guest to make their own travel and transport arrangements to and from their origin/city of residence to London, UK to redeem the prize.

It is also the responsibility of the winner and his/her guest to ensure they meet all travel requirements, including but not limited to passport, visa and insurance.

For the avoidance of doubt, travel insurance, tips, additional food/drinks, hotel extras (*such as minibar, room service, telephone calls, beverages and movies*) and other personal expenses are not included in the Grand Prize.

To qualify for the Grand Prize, participants and their guest must be 18 years or over at the time of participation in the Competition.

## **RUNNER UP PRIZES**

Ten (10) Runner Up prizes will be awarded. Each Runner Up will receive one (1) UEFA Champions League adidas replica match ball. The value of this ball is approximately 60 EUR including VAT.

## **ALLOCATION OF PRIZES**

All Eligible Shipments shipped by Eligible Participants within the Competition Period will be assigned unique identifier/number and entered into the prize draw.

A random draw from all Eligible Shipments will be conducted by a third-party company operating on behalf of FedEx to select one (1) Grand Prize Winner and ten (10) Runner Up winners.

The draw will take place on or before **Monday 29 April 2024**. The draw will determine the winners and no correspondence will be entered into. FedEx's decision will be final.

Every Eligible Participant is eligible to win only one prize during the Competition Period irrespective of how many times they are drawn.

Should the Grand Prize Winner not comply with any of these Terms and Conditions, or fails to respond to FedEx prize communications within the timeframe set out in the winner communications or doesn't meet all the obligations related to the selected Eligible Shipments in-line with FedEx or TNT Conditions of Carriage the prize will be forfeited, and the prize will be allocated to a runner-up in the order drawn.

Should the Runner Up Winners not comply with any of these Terms and Conditions or fail to respond to FedEx prize communications within the timeframe set out in the winner communications, the prize will be forfeited, and additional Runners-Up winners will be drawn.

## **NOTIFICATION TO WINNERS**

**The Grand Prize winner of the Competition will be informed on or before April 30, 2024, and Runner Up winners will be informed on or before May 5, 2024.**

Winners will be sent notification by e-mail to the address provided during registration. Winners must reply within three (3) days from receipt of the e-mail to accept or decline their prize, to the following address [eu-marketingukireland@corp.ds.fedex.com](mailto:eu-marketingukireland@corp.ds.fedex.com).

If the Grand Prize winner fails to respond to FedEx prize communications within the timeframe set out in the winner communications, the prize will be forfeited, and the prize will be allocated to a runner-up in the order drawn.

Once the accuracy of the information provided by the winner has been verified, the prize will be confirmed and instructions for receiving it will be sent by e-mail.

If a Runner Up prize winner does not reply to the FedEx prize communication email, or the winner is unable to accept the prize when delivered, their right to the prize will automatically lapse. In such case, FedEx reserves the right to select additional winners.
