

FedEx offers a range of options for your shipments which may incur additional fees or surcharges. Below you can find more information on these extra services and other useful shipping information

Value Added Services⁽¹⁾ (2)

You can customise your FedEx services to your needs (or the needs of your recipients) with value added services. The following are descriptions of the fees applicable to value added services.

This means it can only be offered in locations where fully regulated Dangerous Goods services are offered. <p>FedEx® Delivery Signature Options</p> <p>The following delivery signature options⁽⁸⁾ may be chosen at the time of booking your shipment. For residential shipments, if no Delivery Signature Option is selected during shipment creation and no one is available to receive the package, FedEx may deliver it to a secure location at the recipient's address, where permitted by local law.</p> <ol style="list-style-type: none"> No Signature Required: FedEx will attempt to obtain a signature at the delivery address. If no one is available to sign, FedEx will deliver the package in a safe place without obtaining signature. <i>The No Signature Required option is not available for residential deliveries in Bulgaria.</i> Indirect Signature Required: FedEx will obtain a signature from someone at the delivery address or from somebody nearby, such as a neighbor or building manager. The recipient has the option to utilize any FedEx-approved means to authorize the shipment to be released without anyone present. Direct Signature Required: FedEx will obtain a signature from someone at the delivery address only. If no one is available to sign, FedEx will attempt to redeliver the package. <p>Additional Handling Surcharge (AHS)</p> <p>Package Services A surcharge applies per package or piece that:</p> <p>Dimension</p> <ul style="list-style-type: none"> • measures greater than 121 centimetres along its longest side; • measures greater than 76 centimetres along its second-longest side; or, • measures greater than 266 centimetres in length and girth – the length and girth is length plus (two times the height) plus (two times the width); • measures greater than 169,901 cubic centimeters in volume (length times width times height). <p>Packages that qualify for AHS – Dimension will be subject to 18kg minimum billable weight.</p> <p>IMPORTANT: If a FedEx package is subject to an Oversize Charge or AHS – Packaging, and also meets the criteria for AHS – Dimension, the minimum billable weight of 18kg will still apply. <p>Additional Handling Surcharge - Non-stackable⁽¹¹⁾</p> <p>A surcharge applies to any freight handling unit of a freight shipment that is non-stackable. Non-stackable means that the freight handling unit cannot be stacked vertically in a safe and secure manner. Examples include, but are not limited to, non-stackable freight handling units that: 1) do not have a flat and stable top or base, 2) may be damaged if another piece is loaded on them, or 3) have flat and stable loading surfaces but are too narrow to safely and securely support other freight handling units (e.g. 1-2 barrels or drums). A surcharge also applies to any freight handling unit identified by the shipper as non-stackable. (15) FedEx international packages will be subject to 18kg minimum billable weight when the package also meets the criteria of AHS – Dimension.
