For customers who have registered for the Global Third-Party service only. For customers registered for the Global Third-Party service, discounts are based on the published Global Third-Party base rates, as indicated in their pricing agreement. For all other customers who have not registered for Global Third-Party service, surcharges applied on third-party shipments will be determined by the originating country/territory.
