## Value Added Services<sup>(2)(3)</sup>

You can customise your FedEx services to your needs (or the needs of your recipients) with value added services from FedEx Express. The following are descriptions of the fees applicable to value added services.

Address Correction	If a recipient's address on an Air Bill, Air Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment. Additional Handling Surcharge – Oversize Charge	<ul> <li>FedEx will assess an Additional Handling Surcharge per eligible package for international multi-piece shipments, instead of per shipment.</li> <li>An oversize charge applies to a package that exceed 243 centimeters in length* or 330 centimeters in length* and girth (L+2W+2H).</li> <li>Package shape and dimensions may change during transit, which can affect the package's surcharge eligibility.
