



## Non-Standard Shipment Demand Surcharge (Indonesia)

Effective September 21, 2026, international non-standard packages that meet the applicable criteria may be subject to a Non-Standard Shipment Demand Surcharge.

Non-Standard Shipment Demand Surcharges will apply to packages meeting the criteria and characteristics of the Additional Handling Surcharge (Dimension, Weight and Packaging)<sup>1</sup>, the Oversize Charge<sup>1</sup>, and the Unauthorized Package Charge<sup>1</sup> in addition to all other applicable charges.
