



Non-Standard Shipment Demand Surcharge (Taiwan)

Effective September 21, 2026, international non-standard packages that meet the applicable criteria may be subject to a Non-Standard Shipment Demand Surcharge.

Non-Standard Shipment Demand Surcharges will apply to packages meeting the criteria and characteristics of the Additional Handling Surcharge (Dimension, Weight and Packaging)¹, the Oversize Charge¹, and the Unauthorized Package Charge¹ in addition to all other applicable charges.

FedEx may also, at its sole discretion, cancel, modify or adjust any waiver of Non-Standard Shipment Demand Surcharge by prior notice.

The surcharge amounts presented above are indicative only and may differ depending on the rate scale or price list for which you have registered with FedEx.
