Fuel Surcharge

The surcharge percentage is adjusted every Monday, based on the US Gulf Coast Jet Fuel Index, and this percentage is applied to the total transportation charge (go to <https://www.fedex.com/en-ph/home.html> for the prevailing fuel surcharge rate and a sample calculation).

Demand Surcharge

During times of elevated shipping volumes, heightened demand for capacity, increased operating costs, and other strains on our network, FedEx may assess a Demand Surcharge.

Special Handling Fees

Address Correction: PHP 586 per shipment

If a recipient's address on an Air Bill, Air Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment.

For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment. If we are unable to complete delivery under these circumstances, we will not be liable for failing to meet our delivery commitment.

Third Party Billing Surcharge: 2.5% of total shipment charges

Third Party Billing Surcharge will apply to shipments that are billed to a third party. The surcharge will be charged to the third-party payer.

The surcharge applies when the shipper account number and the third party billing account number are not part of the same company, as determined by FedEx.

Third Party Consignee Surcharge: PHP 505 per shipment. Please visit <https://www.fedex.com/en-ph/shipping.html> for details.

FedEx International Broker Select: PHP 563 per shipment or PHP 65 per kg, whichever is greater

This surcharge applies when all of the following occur:

- A broker (other than FedEx or FedEx designated) clears the shipment.
- FedEx picks up the shipment at the customer's broker location and delivers it to the final consignee.
- The consignee's location is served by a different clearance point than the broker's clearance point.

Saturday Pick Up: PHP 868 per shipment

Saturday Delivery: PHP 868 per shipment

U.S. Inbound Processing Fee: PHP 85 per shipment. A charge will be assessed on all international shipments imported into the U.S. in connection with the processing of those shipments for customs clearance.

*Out of Pickup Area Surcharge (OPA): Applicable surcharges by tier:

Tier B: PHP 1,200 per shipment or PHP 22 per kg, whichever is greater

Indirect Signature Required (ISR): PHP 169 per non-freight shipment (applicable to U.S./Canada residential destinations with declared value for Carriage less than USD500/CAD500 shipment). Please visit <https://www.fedex.com/en-ph/shipping.html> for details.

Direct Signature Required (DSR): PHP 190 per non-freight shipment (not applicable to U.S./Canada destinations with Declared value for Carriage greater than or equal to USD500/CAD500 shipment). Please visit <https://www.fedex.com/en-ph/shipping.html> for details.

Adult Signature Required (ASR): PHP 233 per non-freight shipment. Please note that FedEx may not reroute shipments when Adult Signature Required has been selected as a delivery signature option. Please visit <https://www.fedex.com/en-ph/shipping.html> for details.

*Residential Delivery Surcharge: PHP 190 per non-freight shipment or PHP 6,148 per freight shipment (applicable to US & Canada destinations only). A residential delivery charge applies to shipments addressed to a home or private residence, including locations where a business is operated from a home, or to any shipment in which the shipper has designated the delivery address as a residence. If the ODA Surcharge is applied to a shipment, the Residential Delivery Surcharge will not apply.

* Residential Delivery Surcharge does not apply to FedEx 10kg or 25kg Box shipments.

Accessible Dangerous Goods: PHP 6,182 per shipment or PHP 102 per kg, whichever is greater. A minimum billable weight may apply. Please visit <https://www.fedex.com/en-ph/shipping.html> for details.

Additional Handling Surcharge - Dimension:	<p>PHP 1,518 per package for IF, IPE, IP & IE. This surcharge applies to any package that measures greater than 121 centimeters along its longest side; measures greater than 76 centimeters along its second-longest side; or measures greater than 266 centimeters in length and girth. If the Oversize Charge is applied to a package, the Additional Handling Surcharge - Dimension will not apply.</p> <p> Subject to an 18kg minimum billable weight.</p>
Additional Handling Surcharge - Weight:	PHP 1,518 per package for IF, IPE, IP & IE. This surcharge applies to any package that measures greater than 31kg in actual weight.
Additional Handling Surcharge - Packaging:	<p>PHP 1,518 per package for IF, IPE, IP & IE. Oversize Charge:	<p>PHP 4,080 per package. This surcharge applies to a package that exceed 243 centimeters in length, or 330 centimeters in length and girth.</p> <p>If a FedEx package is subject to an Oversize Charge, and also meets the criteria for Additional Handling Surcharge - Dimension, the Additional Handling Surcharge - Dimension minimum billable weight of 18kg will still apply.</p> <p> Length is the longest side of a package.</p>
Non-Stackable Surcharge:	PHP 14,200 per freight handling unit for IPF & IEF. This surcharge applies to any freight handling unit that is non-stackable, which means the piece, skid, or pallet cannot be stacked vertically in a safe and secure manner. Examples include, but are not limited to, non-stackable freight handling units that: 1) do not have a flat and stable top or base, 2) may be damaged if another piece is loaded on them, or 3) have flat and stable loading surfaces but are too narrow to safely and securely support other freight handling units (e.g. 1-2 barrels or drums).
Dry Ice Surcharge:	PHP 253 per shipment. If a shipment contains both dry ice and dangerous goods (accessible or inaccessible), only dangerous goods surcharge applies, and dry-ice surcharge is not applied.
Monitoring & Intervention Premium - Package:	PHP 3,955 per shipment or PHP 170 per kg, whichever is greater, for IPE & IP
Monitoring & Intervention Premium - Freight:	<p>PHP 28,250 per shipment or PHP 71 per kg, whichever is greater, for IPF</p> <p>Monitoring & Intervention (M & I) Premium is a specialized, subscription-based and contract-only service specifically designed for customers whose shipments require network sensor (where available), dedicated handling, priority boarding, 24/7 expert support, proactive monitoring and expedited shipment recovery in the FedEx network. FedEx Priority Alert (FPA) is a specialized, fee-based and contract-only service specifically designed for customers requiring a high degree of shipment visibility and delivery compliance. By combining special boarding, enhanced shipment status tracking and operational recovery procedures, FPA provides an enhanced and reliable solution for your shipment. Please note that all requests need to be reviewed prior to acceptance in order to confirm service compliance and availability.

Priority Alert Plus - Package: PHP 3,720 per shipment or PHP 186 per kg, whichever is greater, for IPE & IP

Priority Alert Plus - Freight: PHP 31,000 per shipment or PHP 62 per kg, whichever is greater, for IPF

Our FedEx Priority Alert Plus (FPA+) service includes all the features of FPA as well as pro-active intervention capabilities for temperature sensitive shipments. With FPA+, re-icing, gel pack replenishments & cold storage are included as standard in the service. Please note that all requests need to be reviewed prior to acceptance in order to confirm service compliance and availability.

On-demand Care - Package: PHP 5,375 per shipment or PHP 237 per kg, whichever is greater, for IPE & IP

On-demand Care - Freight: PHP 31,000 per shipment or PHP 124 per kg, whichever is greater, for IPF

On Demand Care (ODC) is a fee-based service for non-food items providing intervention services such as Dry Ice replenishment and gel pack reconditioning/ exchange, to protect the integrity of temperature-controlled shipments delayed in-transit. This service is not available at all locations. This service is not guaranteed and is subject to the identification of the shipment and must be booked via Customer Service.

Duty and Tax: If duties and taxes are levied on a shipment and FedEx pays them on behalf of the party responsible for payment, then that party must reimburse FedEx for the duties and taxes themselves, plus a FedEx surcharge that is based upon the type of shipment and its destination.

Declared Value Charge for Carriage: Liability of FedEx for loss, damage or delay of your shipment is limited to the greater of about USD20.00 per kilogram or USD100.00 per shipment. The exact limitation may be expressed in Special Drawing Rights or local currency and the exact amount will vary depending upon the country/ territory of origin and currency.
If you desire that FedEx assumes liability for a greater percentage of the actual cargo value, then you must declare the value for carriage on your air waybill and pay a "declared value surcharge". The "declared value surcharge" for global third-party shipments paid by Philippines customers is equal to PHP 102 per PHP 4,300 (or fraction thereof) by which the declared value for carriage exceeds the greater of: (i) PHP 4,300 or (ii) PHP 390 per pound. The following maximum declared value for carriage will apply. Please contact FedEx Customer Service team for details.

Weight Information

Total shipment weight is unlimited. The maximum weight per package may be adjusted. Please contact FedEx Customer Service team or Sales team for details.

Rates are calculated on the total weight of all packages on one international air waybill. Any fraction of a kilogram is rounded up to the next higher weight break. Such rounding may cause a variance in dimensional weight (volumetric weight) calculations. Please note that the rates stated on FedEx's invoice shall be the final and official rates.

Additional charges may be assessed for shipments below a certain weight density. The dimensional weight (volumetric weight) (in kg) of an International Priority Express/Priority/Economy shipment is calculated as follows. Please contact FedEx Customer Service team for details.

Length x Width x Height (centimeters or inches)

5,000 for centimeters or 305 for inches

A minimum billable weight of 1 kg applies to FedEx Small Box, FedEx Medium Box and FedEx Large Box; and a minimum billable weight of 4 kg applies to FedEx Tube.

Shipments in FedEx packaging may be subjected to dimensional weight pricing.

In the case of multiple-piece shipments, the invoice weight will be the sum of the higher actual weight or dimensional weight of each individual package.

- Please note that your shipment is governed by several documents: your discount-pricing letter agreement with FedEx (if applicable), the Conditions of Contract printed on the FedEx Air Waybill for your shipment, the FedEx Service Guide, the FedEx Standard Conditions of Carriage, and/or FedEx International Terms and Conditions in effect at the country/ territory of origin. These documents provide for the above surcharges, fees, and other important terms that you should review. If you need assistance or desire additional information, please contact FedEx Customer Service team.
- All rates are exclusive of all applicable tax.
- For Address Correction, if the package is being rerouted to a different Country/ Territory, City or Province, a new shipment fee may apply.
- Total shipment charges includes transportation charges, surcharges and additional fees; but does not include duties, taxes and ancillary clearance service fees. The Third Party Billing Surcharge applies when an account unrelated to the shipper, as solely determined by FedEx, is billed as a third party for the shipment.

FedEx Rate Sheet Terms and Conditions

1. FedEx Envelope and Pak.

- FedEx Envelope and FedEx Pak rates apply if their respective packaging is used.
- Please use one air waybill for each FedEx Envelope shipment.
- FedEx Envelope shipments exceeding 0.5kg will be charged at FedEx Pak rates.
- FedEx Envelope or FedEx Pak shipments exceeding 2.5kg will be charged at International Priority Express (IPE) or International Priority (IP) rates.
- No FedEx Envelope and FedEx Pak rates are available for International Economy (IE) Service. Please use IPE/IP Service if FedEx packaging is needed. Any IE shipment using FedEx Envelope & Pak packaging will be charged at IE rates based on the weight per shipment.

2. FedEx 10kg and 25kg Box.

- FedEx 10kg and 25kg Box rates apply if their respective packaging is used.
- Please use one air waybill for each FedEx 10kg or 25kg Box shipment.
- Recommended maximum actual weight is 25kg for FedEx 10kg Box and 44kg for FedEx 25kg Box. Higher rates will be charged on any FedEx 10kg or 25kg Box shipment with actual weight over 44kg. Please contact our Customer Service Team for more information.

3. Dangerous Goods. Dangerous goods may not be shipped in the FedEx Envelope, FedEx Pak, FedEx 10kg Box, FedEx 25kg Box or via FedEx International Economy (IE) or FedEx International Economy Freight (IEF) service.

4. Advanced Booking Requirement. Air cargo space must be reserved in advance with our Customer Service team for the following shipments:

- For the shipments originating from Asia countries/ territories (Australia, Cambodia, Mainland China, Guam, Hong Kong SAR China, Indonesia, Japan, Macau SAR China, Malaysia, New Zealand, Philippines, Singapore, South Korea, Taiwan China, Thailand, and Vietnam), IPE/IP/IE multiple-piece shipments with an actual weight of more than 500kg, IPF/IEF shipments with an actual weight of more than 100kg or any individual package that measures greater than 274 centimeters along its longest side or measures greater than 203 centimeters along its second-longest side or measures greater than 178 centimeters along its third-longest side; or measures greater than 330 centimeters in its longest side and girth (Length + 2xWidth + 2xHeight).

- For the shipments originating from other countries/ territories, IPE/IP/IE multiple-piece shipments with an actual weight of more than 300kg, or IPF/IEF shipments (regardless of weight).

5. IPF/IEF Minimum Charge. A 68kg minimum rate charge per package shall apply to IPF or IEF shipments weighing less than 68kg. Please contact our Customer Service team for details.

6. Global Third-Party Pricing.

- All services may not be available for some origins and destinations. For service availability information please contact our Customer Service team.
- If a shipment using FedEx 10kg Box weighs above 10kg, or a shipment using FedEx 25kg Box weighs above 25kg, IPE/IP rate will apply without any discount.

7. IPE is available to selected zip codes only. Please contact our Customer Service Team for destination details.
