Declared Value Charge for Carriage:

Liability of Fedex for loss, damage or delay of your shipment is limited to the greater of about USD20.00 per kilogram or USD100.00 per shipment. The exact limitation may be expressed in Special Drawing Rights or local currency and the exact amount will vary depending upon the country/ territory of origin and currency.

If you desire that FedEx assumes liability for a greater percentage of the actual cargo value, then you must declare the value for carriage on your air waybill and pay a "declared value surcharge". The "declared value surcharge" for Export shipments in Japan is equal to JPY 170 per JPY 12,500 (or fraction thereof) by which the declared value for carriage exceeds the greater of: (i) JPY 12,500 or (ii) JPY 1,375 per pound.
