Fuel Surcharge

The surcharge percentage is adjusted every Monday, based on the US Gulf Coast Jet Fuel Index, and this percentage is applied to the total transportation charge (go to <https://www.fedex.com/en-vn/shipping/surcharges.html> for the prevailing fuel surcharge rate).

Demand Surcharge

During times of elevated shipping volumes, heightened demand for capacity, increased operating costs, and other strains on our network, FedEx may assess a Demand Surcharge.

| Address Correction: ¹ | <p>VND 289,200 per delivery address</p> <p>If a recipient's address on an Air Bill, Air Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment.</p> <p>For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment. | U.S. Inbound Processing Fee: | <p>VND 68,300 per shipment. A charge will be assessed on all international shipments imported into the U.S. in connection with the processing of those shipments for customs clearance.</p> | | | | |
| *Out of Pickup Area Surcharge (OPA): | <p>VND 550,000 per shipment or VND 9,200 per kg, whichever is greater</p> <p>* FedEx imposes a surcharge for shipments to areas outside those in which its own couriers pick up cargo (OPA areas). By combining special boarding, enhanced shipment status tracking and operational recovery procedures, FPA provides an enhanced and reliable solution for your shipment. | Priority Alert Plus - Package: | <p>VND 1,737,600 per shipment or VND 86,880 per kg, whichever is greater, for IPD</p> <p>Our FedEx Priority Alert Plus (FPA+) service includes all the features of FPA as well as pro-active intervention capabilities for temperature sensitive shipments. With FPA+, re-icing, gel pack replenishments & cold storage are included as standard in the service. Please note that all requests need to be reviewed prior to acceptance in order to confirm service compliance and availability.</p> | | | | |
| On-demand Care - Package: | <p>VND 2,625,000 per shipment or VND 115,500 per kg, whichever is greater, for IPD</p> <p>On Demand Care (ODC) is a fee-based service for non-food items providing intervention services such as Dry Ice replenishment and gel pack reconditioning/ exchange, to protect the integrity of temperature-controlled shipments delayed in-transit. This service is not available at all locations. This service is not guaranteed and is subject to the identification of the shipment and must be booked via Customer Service.</p> | | | | |

| Declared Value Charge for Carriage: | <p>Liability of Fedex for loss, damage or delay of your shipment is limited to the greater of about USD20.00 per kilogram or USD100.00 per shipment. The exact limitation may be expressed in Special Drawing Rights or local currency and the exact amount will vary depending upon the country/ territory of origin and currency.</p> <p>If you desire that FedEx assumes liability for a greater percentage of the actual cargo value, then you must declare the value for carriage on your air waybill and pay a "declared value surcharge". The "declared value surcharge" for Export shipments in Vietnam is equal to VND 46,800 per VND 2,100,000 (or fraction thereof) by which the declared value for carriage exceeds the greater of: (i) VND 2,100,000 or (ii) VND 190,470 per pound. The following maximum declared value for carriage will apply. Weight Information

Total shipment weight is unlimited. The maximum weight per package may be adjusted. Please contact our Customer Service team or Sales team for details.

Rates are calculated on the total weight of all packages on one international air waybill. Any fraction of a kilogram is rounded up to the next higher weight break. Such rounding may cause a variance in dimensional weight (volumetric weight) calculations. Please note that the rates stated on FedEx's invoice shall be the final and official rates.

Additional charges may be assessed for shipments below a certain weight density. The dimensional weight (volumetric weight) (in kg) of an IPD/IED shipment is calculated as follows. Please contact our Customer Service team for details.

Length x Width x Height (centimetres or inches)

5,000 for centimetres or 305 for inches

Shipments in FedEx packaging may be subjected to dimensional weight pricing.

These documents provide for the above surcharges, fees, and other important terms that you should review. - All rates are exclusive of applicable taxes.
- For Address Correction, if the package is being rerouted to a different Country/ Territory, City or Province, a new shipment fee may apply.
- Total shipment charges includes transportation charges, surcharges and additional fees; but does not include duties, taxes and ancillary clearance service fees. The Third Party Billing Surcharge applies when an account unrelated to the shipper, as solely determined by FedEx, is billed as a third party for the shipment.
