



FedEx offers a range of options for your shipments which may incur additional fees or surcharges. Below you can find more information on these extra services and other useful shipping information.

#### Value Added Services(1)(2)

You can customise your FedEx services to your needs (or the needs of your recipients) with value added services from FedEx. The following are descriptions of the fees applicable to value added services.

# Accessible Dangerous Goods (ADG)

The content of package must be accessible during transit for security reasons.

## Inaccessible Dangerous Goods (IDG)

The content of package does not have to be accessed during transit and can be mixed with other freight.

## • Dry Ice (DI)

Dry ice is a hazardous commodity that requires special handling, subject to simplified regulations. This means it can be offered in locations where fully regulated Dangerous Goods services are not offered.

#### Lithium Batteries Section II (ELB)

Four commodities are covered:

- 1. Lithium Ion packed with equipment (UN 3481 Packing Instruction 966).
- 2. Lithium Ion contained in equipment (UN 3481 Packing Instruction 967).
- 3. Lithium Metal packed with equipment (UN 3091 Packing Instruction 969).
- 4. Lithium Metal contained in equipment (UN 3091 Packing Instruction 970).

In case a shipment contains Dry Ice or Lithium Battery Section II with another Dangerous Good, only the respective (Accessible or Inaccessible) Dangerous Goods surcharge applies.

Note: For Dangerous Goods, only Lithium Batteries Section II (ELB) applies to FedEx® International Connect Plus service (4); only Dry Ice (DI) and Lithium Batteries Section II (ELB) apply to domestic services. 

#### FedEx International Broker Select® Option

A fee applies to FedEx International Broker Select (BSO) shipments when all of the following occur:

- A broker (other than FedEx or FedEx designated) clears the shipment.
- FedEx picks up the shipment at the customer's broker location and delivers it to the final consignee.
- The consignee's location is served by a different clearance point than the broker's clearance point.

### FedEx Priority Alert™ (6)

FedEx Priority Alert (FPA) is a specialised, fee-based and contract-only service specifically designed for customers requiring a high degree of shipment visibility and delivery compliance. By combining special boarding, enhanced shipment status tracking and operational recovery procedures, FPA provides an enhanced and reliable solution for your shipment.

FPA is available for FedEx international and domestic services in markets enabled for FPA. Please note that all requests need to be reviewed prior to acceptance in order to confirm service compliance and availability.

No Signature Required: FedEx will attempt to obtain a signature at the delivery address. If no one is available to sign, FedEx will deliver the package in a safe place without obtaining signature.  2. Indirect Signature Required: FedEx will obtain a signature from someone at the delivery address, from a neighbour or from a building manager. If no one is available to sign, FedEx will attempt to redeliver the package.  3. Direct Signature Required: FedEx will obtain a signature from someone at the delivery address only. If no one is available to sign, FedEx will attempt to redeliver the package.  4. Adult Signature Required: FedEx will obtain a signature from any person of legal age at the delivery address, subject to sighting of a valid ID. Additional Handling Surcharge – Non-stackable <sup>(9)</sup> A surcharge applies to any freight handling unit of a freight shipment that is non-stackable. Non-stackable means that the freight handling unit cannot be stacked vertically in a safe and secure manner. Examples include, but are not limited to, non-stackable freight handling units that: 1) do not have a flat and stable top or base, 2) may be damaged if another piece is loaded on them, or 3) have flat and stable loading surfaces but are too narrow to safely and securely support other freight handling units (e.g. 1-2 barrels or drums). A surcharge also applies to any freight handling unit identified by the shipper as non-stackable. This surcharge applies on a per-freight-handling-unit basis even if multiple pieces of freight are bundled in a shipment. Address Correction  If a recipient's address on an Air Bill, Air Waybill, Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment.  For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill, Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment.
