



## Value Added Services and Surcharges (VASS)

Applicable in France from 7 January 2019

FedEx Express offers a range of options for your shipments which may incur fees or surcharges. Below you can find more information on these extra services and other useful shipping information.

### + Value Added Services<sup>(1)(2)</sup>

You can customize your shipment to your needs (or the needs of your recipients) with value added services from FedEx Express. The following are descriptions of the fees.

<b>Dangerous Goods<sup>(1)</sup></b> Only available on Express Services.	<p>FedEx Express Dangerous Goods services allow the shipping of regulated dangerous substances and materials including door-to-door delivery and customs clearance.</p> <p>Applicable fee depends on the Dangerous Goods type:</p> <ul style="list-style-type: none"> <li>• <b>Accessible Dangerous Goods (ADG)</b> The content of package must be accessible during transit for security reasons.</li> <li>• <b>Inaccessible Dangerous Goods (IDG)</b> The content of package does not have to be accessed during transit and can be mixed with other freight.</li> <li>• <b>Dry Ice (DI)</b> Dry ice is a hazardous commodity that requires special handling, subject to simplified regulations. This means it can be offered in locations where fully regulated Dangerous Goods services are not offered.</li> <li>• <b>Lithium Batteries Section II (ELB)</b> Four commodities are covered:               <ol style="list-style-type: none"> <li>1. Lithium Ion packed with equipment (UN 3481 - Packing Instruction 966).</li> <li>2. Lithium Ion contained in equipment (UN 3481 - Packing Instruction 967).</li> <li>3. Lithium Metal packed with equipment (UN 3091 - Packing Instruction 969).</li> <li>4. <b>Diplomatic Bag (Diplomatic Mail)<sup>(1)</sup></b>	<p>We accept diplomatic shipments between embassies and consulates of the same country/territory for delivery by International Priority service. As per the Vienna Convention of 1961, Diplomatic Bags receive diplomatic immunity from inspection or delay.</p>	Free

<b>FedEx<sup>®</sup> Electronic Trade Documents</b>	With FedEx Electronic Trade Documents (ETD) you can streamline your international shipments by uploading your customs documentation electronically. ETD reduces the amount of paper you print for each shipment, allows for faster pickup and helps to pre-clear your shipments, reducing the risk of your shipment being delayed in customs. ETD feature needs to be activated within your automated shipping tool.	Free
<b>FedEx Global Returns or FedEx Import Shipping Print Label<sup>(1)</sup></b>	Create return or import shipping labels on your computer or shipping system. Then simply print and provide the label to your customer or send it as PDF via email.	Free

<b>FedEx International Broker Select Option<sup>(1)</sup></b>	A fee applies to FedEx International Broker Select (BSO) shipments when all of the following occur: <ul style="list-style-type: none"> <li>• A broker (other than FedEx Express or FedEx Express designated) clears the shipment.</li> <li>• FedEx Express picks up the shipment at the customer's broker location and delivers it to the final consignee.</li> <li>• The consignee's location is served by a different clearance point than the broker's clearance point.</li> </ul>	€1.56/kg <sup>(4)</sup> (minimum €10.40)

By combining special boarding, enhanced shipment status tracking and operational recovery procedures, FPA provides a totally reliable solution for your shipment. It applies to FedEx international and domestic express services. Please note that all requests need to be reviewed prior to acceptance in order to confirm service compliance and availability. With FPA+, re-icing, gel pack replenishments & cold storage are included as standard in the service. It applies to FedEx international and domestic express services. Please note that all requests need to be reviewed prior to acceptance in order to confirm service compliance and availability. <b>On Demand Care<sup>(1)</sup></b>	On Demand Care (ODC) is a fee-based service for non-food items providing intervention services such as Dry Ice replenishment and gel pack reconditioning/exchange, to protect the integrity of temperature-controlled shipments delayed in-transit. This service is not available at all locations. This service is not guaranteed and is subject to the identification of the shipment and must be booked via Customer Service. <b>Third Party Consignee<sup>(1)</sup></b>	FedEx Third Party Consignee International Priority service (TPC) is our value-added service for customers who do not want to reveal the actual commercial value of the shipment and the shipper details to their consignees. This service enables deliveries of shipments to end consignees without a commercial invoice attached.	€15/shipment
<b>FedEx Customs Brokerage Services</b>	FedEx Express offers a seamless standard customs clearance process to enable on-time delivery of your goods. We also offer a range of specialised inbound clearance solutions subject to an additional fee (VAT may apply at the applicable rate). <b>Delivery Signature Options</b>	The following delivery options <sup>(5)</sup> may be chosen at the time of booking your shipment: <ol style="list-style-type: none"> <li><b>No Signature Required:</b> FedEx will attempt to obtain a signature at the delivery address. If no one is available to sign, FedEx will deliver the package in a safe place without obtaining signature.</li> <li><b>Indirect Signature Required:</b> FedEx will obtain a signature from someone at the delivery address, from a neighbour or from a building manager. If no one is available to sign, FedEx will attempt to redeliver the package.</li> <li><b>Direct Signature Required:</b> FedEx will obtain a signature from someone at the delivery address only. If no one is available to sign, FedEx will attempt redelivery of the package.</li> <li><b>Adult Signature Required:</b> FedEx will obtain a signature from any person of legal age at the delivery address, subject to the provision of a valid ID. If no one qualified to sign is available, FedEx will attempt to redeliver the package. Legal age will vary depending on the destination country/territory and is governed by local legal age of an adult, not the legal age to purchase specific products (i.e. alcohol).</li> </ol>	<ol style="list-style-type: none"> <li>Free</li> <li>Free. ## + Surcharges <sup>(1) (2)</sup>

Your transportation costs may be affected by additional charges. The following are descriptions of the surcharges.

<b>Additional Handling Surcharge – Non-stackable<sup>(6)</sup></b>	A surcharge applies to any FedEx International Priority <sup>®</sup> Freight and FedEx International Economy <sup>®</sup> Freight shipment containing at least one piece, skid or pallet that is non-stackable. Non-stackable means that a piece, skid or pallet cannot be stacked vertically in a safe and secure manner. This surcharge applies once per shipment, even if multiple pieces identified as non-stackable are bundled in a shipment.	€154/shipment
<b>Address Correction</b>	If a recipient's address on an Air Bill, Air Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment.  For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment. If we are unable to complete delivery under these circumstances, we will not be liable for failing to meet our delivery commitment.	€7.80/shipment
<b>Extended Area Service</b>	Shipments picked up from or delivered to remote and less accessible locations are assessed an Out-of-Pick-up-Area (OPA) or Out-of-Delivery-Area (ODA) surcharge. <b>Fuel Surcharge</b>	<b>International Fuel Surcharge</b> FedEx Express has adopted a Dynamic Fuel Surcharge according to the variation in the price of kerosene-type jet fuel and reserves the right to apply a fuel surcharge.  <b>Domestic Priority Overnight Fuel Surcharge</b> FedEx Express applies a Dynamic Fuel Surcharge which is based on the automotive gas oil prices from the EU country/territory zone. <b>Saturday Delivery</b>	<p>A surcharge might apply to a delivery performed on a Saturday. <b>Third Party Billing</b>	<p>Third Party Billing Surcharge will apply to shipments that are billed to a third party. The surcharge will be charged to the third-party payer<sup>(7)</sup>.</p> <p>The surcharge applies when the shipper account number and the third party billing account number are not part of the same company, as determined by FedEx.</p>	<p>2.5% of total shipment charges.</p> <p>Total shipment charges includes transportation charges, surcharges and additional fees; but does not include duties, taxes and ancillary clearance service fees.</p>
