| Additional Handling Surcharge – Non-stackable⁽⁹⁾ | <p>A surcharge applies to any FedEx International Priority Freight, FedEx International Economy Freight, FedEx Regional Economy Freight and FedEx Priority Freight shipment containing at least one piece, skid or pallet that is non-stackable. Non-stackable means that a piece, skid or pallet cannot be stacked vertically in a safe and secure manner.
