If no one is available to sign, FedEx will attempt to redeliver the package. 3. Direct Signature Required: FedEx will obtain a signature from someone at the delivery address only. If no one is available to sign, FedEx will attempt to redeliver the package. 4. Adult Signature Required: FedEx will obtain a signature from any person of legal age at the delivery address, subject to sighting of a valid ID. Your transportation costs may be affected by additional charges. The following are descriptions of the surcharges.

Additional Handling Surcharge	Express Package Services A surcharge applies to a shipment containing any package that: (Dimension) 1) measures greater than 121 centimetres along its longest side; 2) measures greater than 76 centimetres along its second-longest side; or, 3) measures greater than 266 centimetres in length and girth (length + 2 x width + 2 x height). Package shape and dimensions may change during transit, which can affect the package's surcharge eligibility. If the dimensions change during transit, FedEx may make appropriate adjustments to the shipment charges at any time.	CHF 50/shipment
	Express Freight Services A surcharge applies to a shipment containing any freight handling unit that measures greater than 157 centimetres along its longest side. We reserve the right to assess additional handling charges for freight and any freight handling unit that requires special handling during transit.	CHF 60/shipment
Additional Handling Surcharge – Non-stackable⁽⁶⁾	A surcharge applies to any FedEx International Priority Freight and FedEx International Economy Freight shipment containing at least one piece, skid or pallet that is non-stackable. Non-stackable means that a piece, skid or pallet cannot be stacked vertically in a safe and secure manner. This surcharge applies once per shipment, even if multiple pieces identified as non-stackable are bundled in a shipment.	CHF 164/shipment
Address Correction	If a recipient's address on an Air Bill, Air Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment. For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment. If we are unable to complete delivery under these circumstances, we will not be liable for failing to meet our delivery commitment.	CHF 12/shipment

Fuel Surcharge	International Fuel Surcharge FedEx Express has adopted a Dynamic Fuel Surcharge according to the variation in the price of kerosene-type jet fuel and reserves the right to apply a fuel surcharge. Domestic Priority Overnight Fuel Surcharge FedEx Express applies a Dynamic Fuel Surcharge which is based on the automotive gas oil prices from the EU country/territory zone. Oversize Charge	An oversize charge applies to a shipment containing packages that exceed 243 centimetres in length or 330 centimetres in length and girth (length + 2 x width + 2 x height). If the dimensions change during transit, FedEx may make appropriate adjustments to the shipment charges at any time.	CHF 60/shipment
Third Party Billing	Third Party Billing Surcharge will apply to shipments that are billed to a third party. The surcharge will be charged to the third-party payer ⁽⁷⁾ .
