Rates Information

Taxes, Duties and Additional Charges

In addition to the transportation rates the following additional charges may apply: (i) customs duties; (ii) taxes; (iii) a fuel surcharge; (iv) an ancillary surcharge; and/or (v) an additional charge for value added services (if selected). For further information regarding the surcharges and additional charges (items iii to v) please contact our sales department. All rates, surcharges and other applicable charges quoted exclude any value added tax (VAT) that may be applicable and which would be added to the charges at the rate in force at the time.

International Out-Of-Delivery-Area and Out-Of-Pickup-Area Surcharges

International shipments (subject to service availability) delivered to or picked up from remote and less-accessible locations are assessed an out-of-delivery area or out-of-pickup-area surcharge.
