## Value Added Services<sup>(3) (4)</sup>

You can customise your FedEx services to your needs (or the needs of your recipients) with value added services from FedEx Express. The following are descriptions of the fees applicable to value added services.

FedEx® Electronic Trade Documents	With FedEx Electronic Trade Documents (ETD) you can streamline your international shipments by uploading your customs documentation electronically. This service is not available at all locations. This service is not guaranteed and is subject to the identification of the shipment and must be booked via Customer Service. FedEx® Delivery Signature Options	<ul> <li>The following delivery signature options<sup>(8)</sup> may be chosen at the time of booking your shipment:</li> <li><b>1. No Signature Required:</b> FedEx will attempt to obtain a signature at the delivery address. If no one is available to sign, FedEx will deliver the package in a safe place without obtaining signature.</li> <li><b>2. Indirect Signature Required:</b> FedEx will obtain a signature from someone at the delivery address, from a neighbour or from a building manager. If no one is available to sign, FedEx will attempt to redeliver the package.</li> <li><b>3. Direct Signature Required:</b> FedEx will obtain a signature from someone at the delivery address only. If no one is available to sign, FedEx will attempt to redeliver the package.</li> <li><b>4. Adult Signature Required:</b> FedEx will obtain a signature from any person of legal age at the delivery address, subject to sighting of a valid ID. If no one eligible to sign is available, FedEx will attempt to redeliver the package. Additional Handling Surcharge – Non-stackable <sup>(9)</sup>	A surcharge applies to any FedEx International Priority Freight, FedEx International Economy Freight and FedEx Regional Economy Freight shipment containing at least one piece, skid or pallet that is non-stackable. Non-stackable means that a piece, skid or pallet cannot be stacked vertically in a safe and secure manner. Examples include, but are not limited to, non-stackable freight handling units that: 1) do not have a flat and stable top or base, 2) may be damaged if another piece is loaded on them, or 3) have flat and stable loading surfaces but are too narrow to safely and securely support other freight handling units (e.g. 1-2 barrels or drums). This surcharge applies once per shipment, even if multiple pieces identified as non-stackable are bundled in a shipment.	€154/shipment
Address Correction	If a recipient's address on an Air Bill, Air Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment. For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill or other shipping documentation. If we cannot determine the correct address clarification or instructions to return the shipment. <b>Declared Value</b> (Declared Value for Carriage for international express parcel and freight services)	<ul> <li>FedEx Express does not provide cargo liability or all-risk insurance for shipments. The Declared Value for Carriage is limited to a maximum amount and may vary by location. The Declared Value for Carriage may not exceed:</li> <li>FedEx® Envelope or Pak: US\$100 per shipment (or equivalent value in local currency);</li> <li>Other services except freight transportation services: US\$50,000 per shipment (or equivalent value in local currency);</li> <li>IPF, IEF and REF: US\$100,000 per shipment to most destinations (or equivalent value in local currency);</li> <li>For certain Unique Items: US\$1,000 per shipment (see our Terms and Conditions of Carriage for full details);</li> <li>Actual value of the contents of the shipment;</li> <li>Declared Value for Customs: The selling price or replacement cost of the shipment contents as required for Customs clearance purposes.</li> </ul>	Declared value rates are incremental and depend on the amount the customer declares. 
