### Declared Value Fees that will become effective September 9<sup>th</sup>, 2019

The Declared Value for Carriage fee is Bs.S 17.857,8 per Bs.S 1.841.010 in declared value, with the first Bs.S 1.841.010 or Bs. S 166.979,61 per kg (whichever is greater) free. The maximum Declared Value for Carriage varies by country and type of service, but shall not exceed Bs.S 920.505.000 per shipment (Bs. S 1.841.010.000) for FedEx International Priority Freight shipments), For Items of Extraordinary Value, there is a limit of Bs.S 18.410.100 or less, depending upon destination country. The Declared Value for Carriage may not exceed the Declared Value for Customs.
