Demand surcharge rates below are effective December 22, 2025, through February 15, 2026. Rates are expressed in USD for all countries except for Martinique and Guadeloupe. Rates for Martinique and Guadeloupe are expressed in Euros. Demand surcharge rates do not include taxes.
