Value Added Services⁽¹⁾

You can customise your FedEx core services shipments to your needs (or the needs of your recipients) with value added services from FedEx Express. The following are descriptions of the fees applicable to value added services.

FedEx® Electronic Trade Documents (ETD) and Electronic With Originals (EWO)	<p>With FedEx Electronic Trade Documents (ETD) you can streamline your international shipments by uploading your customs documentation electronically. ETD reduces the amount of paper you print for each shipment, allows for faster pickup and helps to pre-clear your shipments, reducing the risk of your shipment being delayed in customs. ETD feature needs to be activated within your automated shipping tool.</p> <p>EWO-Electronic with Originals (EWO) enables customers to upload customs documents for countries/territories that require paper copies for customs clearance. Uploading documents enables early broker reviews of documentation and advanced notice to resolve issues, minimizing the chance of missing paperwork.</p>	None

Third Party Consignee	FedEx Third Party Consignee International Priority service (TPC) is our value-added service for customers who do not want to reveal the actual commercial value of the shipment and the shipper details to their consignees. Surcharges

Your transportation costs may be affected by additional charges. The following are descriptions of the surcharges.

Additional Handling Surcharge	<p>Express Package Services A surcharge applies to a shipment containing any package that:</p> <p>(Dimension)</p> <ol style="list-style-type: none"> 1) measures greater than 121 centimeters along its longest side; 2) measures greater than 76 centimeters along its second-longest side; or, 3) measures greater than 266 centimeters in length and girth (L+2W+2H). <p>(Weight)</p> <ol style="list-style-type: none"> 1) has a weight greater than 31 Kg; <p>Package shape and dimensions may change during transit, which can affect the package's surcharge eligibility. If the dimensions change during transit, FedEx may make appropriate adjustments to the shipment charges at any time. Additional Handling Surcharge - Non-stackable	<p>A surcharge applies to any FedEx International Priority Freight and FedEx International Economy Freight shipment containing at least one piece, skid or pallet that is non-stackable. Non-stackable means that a piece, skid or pallet cannot be stacked vertically in a safe and secure manner. This surcharge applies once per shipment, even if multiple pieces identified as non-stackable are bundled in a shipment.</p>	₹ 11,565/shipment
Address Correction	<p>If a recipient's address on an Air Bill, Air Waybill or shipping label is incomplete or incorrect, we may attempt to find the correct address and complete delivery and we will assess a surcharge. If we are unable to complete delivery, we are not liable for failing to meet our delivery commitment.</p> <p>For FedEx International Broker Select, the address correction surcharge will apply if the broker's address is incomplete or incorrect on the Air Waybill or other shipping documentation. If we cannot determine the correct address or cannot reach the broker, we may attempt to contact the sender for address clarification or instructions to return the shipment. Minimum Billable Weight	A minimum billable weight applies to consignments packaged in FedEx Express boxes and tubes. The charge is not applicable for FedEx [®] 10kg Box and FedEx [®] 25kg Box consignments. The values are defined as follows: 1. FedEx Box (all sizes)..... 1 kg 2. FedEx Tube..... 4 kg	
Oversize Charge	An oversize charge applies to a shipment containing packages that exceed 243 centimeters in length or 330 centimeters in length and girth (L+2W+2H). Package shape and dimensions may change during transit, which can affect the package's surcharge eligibility. If the dimensions change during transit, FedEx may make appropriate adjustments to the shipment charges at any time.	₹ 2,106/shipment
Saturday Delivery	Charge for delivery of consignments on Saturday.	₹ 1,500/shipment
Third Party Billing	Third Party Billing Surcharge will apply to shipments that are billed to a third party. The surcharge will be charged to the third-party payer ⁽⁶⁾ . The surcharge applies when the shipper account number and the third party billing account number are not part of the same company, as determined by FedEx.	2.5 % of total shipment charges. Total shipment charges includes transportation charges, surcharges and additional fees; but does not include duties, taxes and ancillary clearance service fees.
