

**FedEx Office Passion on Display Sweepstakes Official Rules (“Rules”)
No Purchase Necessary to Enter or to Win.**

1. **Eligibility:** FedEx Office Passion on Display Sweepstakes (“Sweepstakes”) is open to legal residents of the fifty (50) United States and the District of Columbia (the “U.S.”), who have reached the age of majority in their state of residence as of the date of entry. The Sweepstakes is also open to businesses that are lawfully registered and operate in the U.S. The business owners or authorized employees who enter on behalf of the business must be legal residents of the U.S. who have reached the age of majority in their state of residence as of date of entry. Employees of Federal Express Corporation (“Sponsor”), Don Jagoda Associates, Inc. (“Administrator”), Union of European Football Associations and its affiliated leagues, competitions, teams, and organizations (“UEFA”), Counterpart Communication Design, and each of their respective parent and affiliate companies (collectively with Sponsor, Administrator, UEFA, Counterpart Communication Design, (the “Promotion Parties”) as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Subject to all applicable laws and regulations. Void outside the U.S. and where prohibited. Eligible persons/businesses who participate in the Sweepstakes will be referred to as "Participant", "you" or "your" in these Rules. Participation constitutes Participant’s full and unconditional agreement to these Rules and Sponsor’s and Administrator’s decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. FedEx account (if you have one) must be in good standing, as determined by Sponsor in its sole discretion.

2. **Sweepstakes Timing:** Sweepstakes begins at 10:00 a.m. Eastern Time (“ET”) on March 2, 2026 and ends at 5:00 p.m. ET on March 31, 2026 (“Sweepstakes Period”).

3. **How to Enter: There are two (2) ways to Enter the Sweepstakes:**
 - 1) **Making a Qualifying FedEx Office Purchase:** During the Sweepstakes Period, Participants can enter by visiting www.office.fedex.com/printsweepstakes completing all required fields on the onscreen entry form. Participants must make a qualifying FedEx Office purchase, either in store or online, as listed in the chart below (“Purchases*”), and provide the Transaction Number, or Order Number, from the receipt to receive the corresponding number of entries based on the chart below (each, a “Purchase Entry”) into the Sweepstakes.

- 2) Via Mail-in Entry: To enter without making a Qualifying FedEx Office Purchase, you may hand print your complete full name, business name (if applicable), FedEx Office Account Number (if available) and valid email address on a plain piece of 3” x 5” paper. Mail it in a hand-addressed, business-size (#10) envelope with first-class postage affixed, to: FedEx Office Passion on Display Sweepstakes, P.O. Box 7690, Melville, NY 11775-7690 (“Mail-in Entry”). All Mail-in Entries must be postmarked by March 31, 2026 and received by April 7, 2026. There is a limit of one (1) Mail-in Entry per envelope. Each Mail-in Entry is equivalent to five (5) Purchase Entries. All handwritten Mail-in Entries must be sufficiently legible to permit accurate interpretation and verification.

Purchase Entries and Mail-in Entries will be collectively referred to as (“Entries”). Limited to the equivalent of two hundred (200) Purchase Entries per Participant, regardless of method of Entry or combination of methods of Entry. In the event of a dispute as to any Entry, the authorized account holder (as determined by the business owner, if applicable) of the FedEx Office Account Number used to register for the Sweepstakes will be deemed to be the Participant. The “authorized account holder” of the FedEx Office Account Number is the natural person/business assigned to the FedEx Office Account Number by FedEx. A potential winner may be required to show proof of being the authorized account holder of the FedEx Office Account Number or proof of being an authorized representative of the business associated with the FedEx Office Account Number. In the event of a dispute as to any Entry not affiliated with a FedEx Office Account Number, the authorized account holder of the email address used to register for the Sweepstakes will be deemed to be the Participant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. A potential winner who entered without a FedEx Office Account Number may be required to show proof of being the authorized account holder of the email address associated with Entry. Normal internet access and usage charges imposed by your internet service provider will apply. Proof of sending or

submission will not be deemed to be proof of receipt by Sponsor. All Entries become the property of the Sponsor and will not be returned.

4. **Prizes: Grand Prize (1):** A 7-day/6-night for two (2) to the UEFA Champions League Final in Budapest, Hungary, including round-trip economy class air transportation from major airport nearest winner's home to Budapest, round-trip ground transfers to/from airport/hotel, hotel accommodations for six (6) nights (based on double occupancy and availability), two (2) tickets to the UEFA Champions League Final, round-trip ground transfers to/from hotel/arena and \$1,000 awarded as a check for winner only. The approximate retail value of the Grand Prize is estimated at \$11,725. **First Prize (1):** \$4,000, awarded as a check. **Second Prizes (2):** \$2,000, awarded as a check. Limit one (1) prize per Participant.
5. **Drawing:** The winners will be selected in a random drawing on or about April 14, 2026, from among all eligible Entries received/postmarked during the Sweepstakes Period. Drawing will be conducted by the Administrator, an independent judging organization whose decisions are final on all matters relating to this Sweepstakes. Odds of winning a prize depend upon the total number of eligible Entries received/postmarked during the Sweepstakes Period.
6. **General Rules:** Sponsor reserves the right to substitute a prize of equal or greater value if any advertised prize (or portion of prize) is unavailable for any reason. No substitution or transfer of prize by Participant/winner is permitted, other than as described above. Winners will not receive difference between actual and approximate retail value. Taxes related to prizes are the responsibility of the individual winners/winning businesses. Winners/winning businesses will be issued a 1099 tax form for the actual value of the prize received in the year that prize is awarded. Potential Grand Prize winner will be required to execute and return via email, a declaration of eligibility and liability/publicity release (where legal) ("Declaration Package") within forty-eight (48) hours of attempted notification, or the prize may be forfeited and an alternate winner will be selected, time permitting (for the Grand Prize). If a winner wins on behalf of a business, the authorized employee who entered on behalf of the business must complete the Declaration Package and if they wish, they may transfer the prize to another employee at their business and in that event the transferred employee would be deemed the potential winner and must also execute a Declaration Package prior to prize acceptance. Business participants bear the sole responsibility to ensure that their business policy does not prohibit the awarding of a prize to an employee prior to prize acceptance. Grand Prize trip must be taken on dates specified by Sponsor surrounding UEFA Champions League Final, which are subject to change. If the Grand Prize winner is unable to travel on dates specified and agreed to, prize will be forfeited with no compensation and an alternate Grand Prize winner will be selected, time permitting. Sponsor will determine airline and flight itinerary in its sole discretion. Airline carrier's regulations and conditions apply. No refund or compensation will be made in the event of the cancellation or delay of any flight. Travel and accommodations are subject to availability. Travel is subject to the terms and conditions set forth in this Sweepstakes, and those set forth by the Sponsor's airline carrier of choice as detailed in the passenger ticket contract. Trip may not be combined with any other offer and travel may not qualify for frequent flyer miles. Travel companion must travel on same itinerary and at the same time as the Grand Prize winner. If a travel companion is a minor, the Grand Prize winner must be the travel companion's parent or legal guardian. Travel companion (or Grand Prize winner on behalf of minor travel companion) must execute a liability/publicity release (where legal) prior to issuance of travel documents. The Grand Prize winner and their travel companion must possess valid travel documents (e.g. passport, passport card, visa, etc.) in order to travel. Travel restrictions, conditions and limitations may apply. Grand Prize winner and their travel companion must follow any applicable Covid or other protocols required at time of travel. In the event the Grand Prize winner or their travel companion engages in behavior that (as determined by Sponsor in Sponsor's sole discretion) is inappropriate or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate the trip and/or eject them from any applicable event, with no further compensation to the Grand Prize winner. Sponsor will not replace any lost, mutilated, or stolen tickets, travel vouchers or certificates. Actual value may vary based on airfare fluctuations and distance between departure and destination and any difference in value will not be awarded. All other expenses and costs, not expressly listed above, including, but not limited to, taxes, insurance, telephone charges, room service and laundry services, personal expenses, gratuities, entertainment, transfers, incidental charges, or any other items not specifically described in these Rules, any transportation not mentioned within the prize description and all expenses for any of the foregoing are the sole responsibility of the Grand Prize winner. In the event that UEFA Champions League Final is cancelled or postponed for any reason, that portion of the prize will not be awarded and no additional compensation will be provided. First and Second Prize winners will be required to execute and return via email a Declaration package within seven (7) days of attempted notification, or the prize may be forfeited and an alternate winner will be selected. Return of any prize or prize notification as undeliverable will result in disqualification and alternate selection. Prize winners (who have a FedEx account) must have a FedEx account in good standing, at time of prize award as determined by Sponsor in its sole discretion. Prize winners must also be in good standing with their employer, if applicable, at time of prize award or prize will be forfeited. The Promotion Parties are not responsible for lost, late, illegible, mutilated, misdirected or postage-due mailed Entries; technical, hardware or software malfunctions; telephone failures of any kind; lost or

unavailable network connections; or failed, incorrect, inaccurate, incomplete, garbled or delayed electronic or other communications, whether caused by the sender or by any of the equipment or programming associated with or utilized in this Sweepstakes, that may limit the ability to participate, or whether caused by any human error that may occur in the processing of the Entries in the Sweepstakes. Sponsor reserves the right to modify or cancel the Sweepstakes if it is technically corrupted in any way, at its sole discretion, and award the applicable prizes from among all eligible Entries received/postmarked prior to cancellation. Acceptance of a prize constitutes permission to use each winner's name and winning business' name (as applicable) for promotional purposes without further compensation or permission except where prohibited by law, without further compensation or permission from winner or winning business as applicable. The Promotion Parties will have no liability or responsibility for any claim arising in connection with participation in this Sweepstakes or use of any prize that is awarded and assume no responsibility for any injury or damage to Participants or to any other person's computer relating to or resulting from entering this Sweepstakes. By receipt of any prize, each winner agrees, on behalf of themselves or their business (as applicable), to release, indemnify and hold harmless the Promotion Parties from and against any claims or causes of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of any prize ("Claims"). Participant also irrevocably waives all claims against UEFA and its employees, officers, directors, and agents and agrees that UEFA will have no liability or responsibility for any claim arising in connection with participation in this Sweepstakes or the prizes awarded. By participating in this Sweepstakes, each Participant agrees to be bound by the Rules and the decisions of the Sponsor/Administrator.

7. **Disputes:** Participants, winners, and Grand Prize winner's travel companion agree that: (a) they release and will defend, indemnify and hold harmless the Promotion Parties from and all any and all Claims; (b) Claims arising out of or connected with this Sweepstakes, or the prizes awarded shall be resolved individually, without resort to any form of class action, and solely and exclusively in a federal or state court located in Shelby County, Tennessee; (c) Participant submits to sole and exclusive personal jurisdiction to said courts in the State of Tennessee for any such dispute and irrevocably waives any and all rights to object to such jurisdiction; (d) any and all Claims, judgments, and awards shall be limited to actual damages of no more than \$100, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (e) under no circumstances will Participant be permitted to obtain awards for and Participant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Rules, or the rights and obligations of Participants or the Promotion Parties in connection with this Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of Tennessee, without giving effect to any choice of law or conflict of law rules of provisions (whether of the State of Tennessee or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Tennessee.
8. **Data Protection/Privacy Notice:** Information collected by Sponsor in connection with this Sweepstakes may be used by Sponsor in accordance with the online Privacy Notice posted on <https://www.office.fedex.com/default/privacy-notice> and applicable data protection laws and may be provided to Sponsor's third parties involved in administration of the Sweepstakes. Their Terms of Service also apply and you may see them at <https://www.office.fedex.com/default/terms-of-service>. Third parties who assist Sponsor with the administration of the Sweepstakes are authorized to use your information for the sole purpose of Sponsor's administration of the Sweepstakes. By selecting the option to receive promotional emails from Sponsor, Participant agrees to receive future emails from any FedEx operating company. The Participant agrees to the collection, processing and storage of his or her personal data by Sponsor for purposes of the Sweepstakes.
