

FedEx Drop Off, Win Big Sweepstakes Official Rules No Purchase Necessary to Enter or to Win.

- 1. Eligibility: The FedEx Drop Off, Win Big Sweepstakes ("Sweepstakes") is open to businesses that are lawfully registered and operated in the fifty (50) United States and District of Columbia. Businesses that have a FedEx business account must have a FedEx business account in good standing for a small or medium business, as determined by the Sponsor in its sole discretion The business owners or authorized employees who enter on behalf of the business must be legal residents of the 50 United States or the District of Columbia who are 18 years of age or older as of date of entry. Employees of FedEx Corporate Services, Inc. ("Sponsor"), Don Jagoda Associates ("Administrator"), Hawkeye, Inc., and each of their respective parent and affiliate companies (collectively with Sponsor, Administrator, and Hawkeye, Inc., the "Promotion Parties") as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Subject to all applicable laws and regulations. Void where prohibited. Eligible businesses who participate in the Sweepstakes will be referred to as "Participant", "you" or "your" in these Rules. Participation constitutes Participant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. FedEx business account, if applicable, must be in good standing, as determined by Sponsor in its sole discretion.
- **2. Sweepstakes Timing:** Sweepstakes begins at 10:00 a.m. Eastern Time ("ET") on October 18, 2021 and ends at 5:00 p.m. ET on January 31, 2022 ("Sweepstakes Period").
- 3. How to Enter the Sweepstakes: During the Sweepstakes Period, eligible Participants with a FedEx business account can register at https://www.fedex.com/en-us/sweepstakes/holiday-drop-off.html by completing all required fields of the onscreen registration form, including providing your 9-digit FedEx business account number, to receive one (1) entry into the Sweepstakes ("Registration Entry"). Multiple Participants can be registered with the same FedEx account number. By registering a FedEx account number as a business, you affirm and acknowledge that you are an owner or authorized representative of the FedEx account number, and are authorized to enter using such account number. If you do not have a 9-digit FedEx business account number and do not wish to sign up for one, but do wish to enter the Sweepstakes, you may hand-print your full name, business name, full address, date of birth and email address on a 3" x 5" piece of paper and mail it in a separate hand-addressed, stamped envelope with sufficient postage to be mailed to:

 The FedEx Drop Off, Win Big Sweepstakes-Registration Entry, P.O. Box 7770, Melville, NY 11775- 7770. Limit one (1) Registration Entry, regardless of entry method. Mail-in must be complete to be eligible and must be postmarked by January 31, 2022 and received by February 7, 2022 to be eligible. Mechanically reproduced or automated mail-in entries are not eligible.

There are three (3) ways to earn additional entries:

- 1.) Process an eligible FedEx Drop Off: If you registered your 9-digit FedEx business account number, you may earn additional entries by completing a FedEx Ground® or FedEx Express® package drop off at any FedEx drop off location using a valid and eligible FedEx business account number that was registered for the Sweepstakes and is in good standing, as determined by the Sponsor in its sole discretion. Any drop off that is completed on a Wednesday, Thursday or Friday will earn one (1) bonus entry. A drop off will be deemed completed at the time FedEx takes possession and scans the package, which for operational, scheduling and other reasons may be a different day than the day you drop off the package. For example, if you drop a package at a FedEx Drop Box on Tuesday night and FedEx picks up the package on Wednesday, you will earn a bonus entry. However, if you drop off a package late on Friday that is not picked up by FedEx until the following Monday, you will not earn a bonus entry. All determinations concerning bonus entries will be at the sole discretion of FedEx.
- 2.) <u>Return label Entry:</u> If you registered your 9-digit FedEx business account number, you may earn additional entries by offering FedEx return labels with their shipments. For every shipment where a customer uses one of your FedEx return labels to ship a return, Participant will earn one (1) entry into the Sweepstakes.
- 3.) Mail-in Entry: If you registered your 9-digit FedEx business account number, you may earn additional entries by hand-printing your full name, business name, full address, date of birth, email address and 9-digit FedEx business account number on a 3" x 5" piece of paper and mailing it in a separate hand-addressed, stamped envelope with sufficient postage to be mailed to: The FedEx Drop Off, Win Big Sweepstakes, P.O. Box 7770, Melville, NY 11775- 7770. If you do not have a 9-digit FedEx business account number and have sent a registration mail-in entry, you may earn additional entries by hand-printing your full name, business name, full address, date of birth, and email address on a 3" x 5" piece of paper and mailing it in a separate hand-addressed, stamped envelope with sufficient postage to be mailed to: The FedEx Drop Off, Win Big Sweepstakes, P.O. Box 7770, Melville, NY 11775- 7770. Limit one (1) mail-in entry per envelope. Each mail-in entry will be equivalent to two (2) mail-in



entries. All mail-in entries must be complete to be eligible. All mail-in entries must be postmarked by January 31, 2022 and received by February 7, 2022 to be eligible. Mechanically reproduced or automated mail-in entries are not eligible.

Limit two hundred (200) entries per Participant, regardless of method of entry or combination of methods of entry (including bonus entries). An email address may only be used once. You may not enter the same email address with different FedEx accounts. In the event of a dispute as to any entry, the authorized account holder (as determined by Sponsor) of the FedEx account number used to register for the Sweepstakes (or authorized email account holder, if entry was earned via mail-in) will be deemed to be the Participant. The "authorized account holder" is the natural person/business assigned to the FedEx account number by FedEx or the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address, as applicable. A potential winner may be required to show proof of being the authorized account holder or proof of being an authorized representative of the business associated with the FedEx account number (if applicable). Normal internet access and usage charges imposed by your internet service provider will apply. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. All entries become the property of the Sponsor and will not be returned.

- **4. Prizes (awarded to businesses): Grand Prizes (3):** \$10,000, awarded in the form of a check made out to the winning business. **First Prizes (10):** \$5,000, awarded in the form of a check made out to the winning business.
- 5. Drawing: The winners will be selected in a random drawing on or about February 15, 2022, from among all eligible entries received/postmarked during the Sweepstakes Period. Drawing will be conducted by the Administrator (at their office in Melville, NY), an independent judging organization whose decisions are final on all matters relating to this Sweepstakes. Odds of winning a prize depend upon the total number of eligible entries received/postmarked during the Sweepstakes Period. Limit one prize per winning business. Prizes will be awarded and winners will be notified by the Administrator.
- 6. General Rules: Sponsor reserves the right to substitute a prize of equal or greater value if any advertised prize is unavailable for any reason. No substitution or transfer of prize by Participant/winner is permitted, other than as described above. Taxes related to the prizes are the responsibility of the winning businesses. Grand and First Prize winners will need to provide their taxpayer ID# for tax reporting purposes. Each potential Grand and First Prize winner will be required to execute and return, via email, a declaration of eligibility and liability/publicity release (where legal) ("Declaration package") within five (5) business days of attempted notification, or the prize will be forfeited and an alternate winner will be selected. The authorized employee who entered on behalf of the business must complete the Declaration Package or advise the Administrator on the authorized business owner's contact information who must then execute the Declaration Package prior to prize acceptance. Winning businesses that have a qualifying FedEx business must have an account in good standing at time of prize award as determined by Sponsor in its sole discretion. The Promotion Parties are not responsible for lost, late, illegible, mutilated, misdirected or postage-due mailed entries; technical, hardware or software malfunctions; telephone failures of any kind; lost or unavailable network connections; or failed, incorrect, inaccurate, incomplete, garbled or delayed electronic or other communications, whether caused by the sender or by any of the equipment or programming associated with or utilized in this Sweepstakes, that may limit the ability to participate, or whether caused by any human error that may occur in the processing of the entries in the Sweepstakes. Sponsor reserves the right, at its sole discretion, to modify or cancel the Sweepstakes if it is technically corrupted in any way or if there are any situations that may arise (including, but limited to, acts of God, war, pandemics, natural disasters or weather-related), at its sole discretion, and award the prizes from among all eligible entries received/postmarked prior to cancellation. Acceptance of a prize constitutes permission to use each winning business' name and photographs/videos/testimonials for promotional purposes without further compensation or permission from winning businesses except where prohibited by law. The Promotion Parties will have no liability or responsibility for any claim arising in connection with participation in this Sweepstakes or use of any prize that is awarded, and assume no responsibility for any injury or damage to Participants or to any other person's computer relating to or resulting from entering this Sweepstakes. By receipt of prize, each winning business agrees to release, indemnify and hold harmless the Promotion Parties from and against any claims or causes of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of any prize ("Claims"). By participating in this Sweepstakes, each Participant agrees to be bound by these Official Rules and the decisions of the Sponsor/Administrator.
- 7. **Disputes:** Participant agrees that: (a) he/she releases and will defend, indemnify and hold harmless the Promotion Parties from and all any and all Claims; (b) Claims arising out of or connected with this Sweepstakes, or the prize awarded shall be resolved individually, without resort to any form of class action, and solely and exclusively in a



federal or state court located in western Tennessee, Shelby County; (c) Participant submits to sole and exclusive personal jurisdiction to said courts in the State of Tennessee for any such dispute and irrevocably waives any and all rights to object to such jurisdiction; (d) any and all Claims, judgments, and awards shall be limited to actual damages of no more than \$100, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (e) under no circumstances will Participant be permitted to obtain awards for and Participant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of Participants or the Promotion Parties in connection with this Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of Tennessee, without giving effect to any choice of law or conflict of law rules of provisions (whether of the State of Tennessee, the United States, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Tennessee.

Data Protection/Privacy Policy: Information collected by Sponsor in connection with this Sweepstakes may be used by Sponsor and shared with third parties involved in administration of the Sweepstakes in accordance with the online Privacy Policy posted on http://www.fedex.com/us/security/privacy-policy-us.html and applicable data protection laws. The Participant agrees to the collection, processing and storage of his or her personal data by Sponsor for purposes of the Sweepstakes. By selecting the option to receive promotional emails from Sponsor, Participant agrees to receive future emails from any FedEx Operating Company. The data controller and the data recipient is FedEx Corporate Services, Inc.
