FedEx Freight offers **optional and additional services** to easily customize each shipment. Here are the facts on our most popular optional and additional services effective Jan. 2, 2017.<sup>1</sup>

## Optional and additional service info

**CARRIER LIABILITY COVERAGE:** Item 420: See Item 420 in the FXF 100 Series Rules Tariff.

**COLLECT ON DELIVERY (COD):** Item 430: COD amount to be collected — 6% of the COD amount, \$120 minimum charge, \$40 for changes to COD terms.

**DETENTION:** Item 500: With power — \$50 per 28-foot trailer each 15 minutes, \$58 minimum charge. Without power — \$163 per 28-foot trailer each 24 hours.

**EXHIBITION SITES:** Item 520: Rated at Class 150, actual class or applicable exception class (whichever is greater) plus \$128 per shipment; see rule for additional charges to specific locations.

**EXTREME LENGTH:** Item 530: \$150 per shipment when containing any shipping unit or piece with a dimension of 12 feet or greater in length.

**HAZARDOUS MATERIAL HANDLING:** Item 920: \$25 per shipment.

**INSIDE PICKUP OR DELIVERY:** Item 566: \$11.96 per hundredweight, \$126 minimum charge, \$1,264 maximum charge.



**LIFTGATE SERVICE:** Item 890: \$8.33 per hundredweight, \$123 minimum charge, \$406 maximum charge.

**LIMITED ACCESS PICKUP OR DELIVERY:** Item 750-8: \$130 per shipment (includes construction sites, mine sites, churches, schools, etc.).

**NON-BUSINESSTIME SERVICE:** Item 753: \$177 per person per hour or fraction thereof; the minimum charge for non-business hours is \$359 per person, non-business days \$665 per person. Refer to item 753 for additional charges.

**NOTIFICATION PRIOR TO DELIVERY:** Item 750-3: \$55 per shipment.

**PROTECTION FROM FREEZING SERVICE:** Item 810: \$3.09 per hundredweight, \$29 minimum charge.

**RECONSIGNMENT:** Item 820: See Item 820 in the FXF 100 Series Rules Tariff.

**REDELIVERY:** Item 830: \$12.57 per hundredweight, \$126 minimum charge, \$1,316 maximum per shipment.

**RESIDENTIAL PICKUP OR DELIVERY:** Item 750-2: \$130 per shipment.

**SORTING AND SEGREGATING:** Item 887: \$2.86 per hundredweight or \$1.09 per piece, whichever produces the higher charge; \$115 minimum charge.

STORAGE: Item 910: \$3.59 per hundredweight per 24 hours, minimum charge \$36 per shipment per 24 hours, not less than \$126 per shipment; see rule for maximum charges.

WEIGHT AND FREIGHT INSPECTION VALIDATION: Item 981: \$25 validation fee applies when weight difference is found to be 50 lbs. greater or 200 lbs. less than the stated weight on the Bill of Lading.

US/CANADA CROSS-BORDER PROCESSING FEE: Item 481: \$21 will apply on all cross-border shipments moving between points in Canada and points in the United States.

## Value-added services

A.M. DELIVERY: Item 757: Delivery by 10:30 a.m. on the standard due date. \$100 up-charge.<sup>2</sup>

CLOSE OF BUSINESS DELIVERY: Item 756: Delivery by 5 p.m. on the standard due date or get your money back. \$85 up-charge, except for standard rate tariff customers using FedEx Freight® Priority who receive a no-fee money-back guarantee.

CUSTOM DELIVERY WINDOW: Item 761: Select delivery on, before or after a date, or between two dates, as long as it's on or after the standard delivery day.
