	(a) FedEx has no obligation for carriage of any shipment unless, subject to any and all other applicable terms and conditions, the Sender appropriately tenders, and FedEx accepts, shipments subject to Payor's RPI Request.				
	(b) this document is developed and shall serve as a note of information to FedEx only;				
	(c) neither your Request, nor any act of FedEx in responding to your Request or anything contained in this document shall be regarded or construed as constituting any agreement or other binding commitment of FedEx for accepting, transporting or delivering any shipment; and				
	(d) this document is not an air waybill, cargo receipt, consignment note, record of carriage or any other document which may have similar particular meaning and legal effect under applicable conventions, treaties, laws or regulations.
