



Peak surcharges and fees for international services

Updated March 3, 2022

Due to continued disruptions in the global supply chain, air cargo capacity remains limited. We are incurring incremental costs as we continue to adjust our international networks and operate in this constrained environment.

Beginning March 7, 2022, the Peak Surcharge amount for FedEx Express parcel and freight shipments and TNT shipments will increase for some shipments moving between APAC and countries in APAC, Europe, LAC, and MEISA.

Beginning March 7, 2022, the Peak Surcharge amount for FedEx Express parcel and freight shipments and TNT shipments will increase for some shipments moving between Europe and countries in all regions.

Beginning March 7, 2022, the Peak Surcharge amount for FedEx Express parcel and freight shipments and TNT shipments will increase for some shipments moving between India and countries in APAC, Europe, and MEISA.
