

Peak surcharges and fees for international services

Updated April 7, 2022

Due to continued disruptions in the global supply chain, air cargo capacity remains limited. We are incurring incremental costs as we continue to adjust our international networks and operate in this constrained environment.

Beginning April 11, 2022, the Peak Surcharge amount for FedEx Express parcel and freight shipments and TNT shipments will increase for some shipments moving between APAC and various countries.

Beginning April 11, 2022, the Peak Surcharge amount for FedEx Express parcel and freight shipments and TNT shipments will increase for some shipments moving between MEISA and various countries.

Beginning April 11, 2022, the Peak Surcharge amount for FedEx Express parcel and freight shipments will increase for some shipments moving between Europe and China.
