When do you need a Commercial Invoice?



### What is required for the Commercial Invoice?

- The shipper's and recipient's complete information
- Importer of Record
- The buyer's information (the person to whom the goods are sold by the seller), if different from the recipient
- Harmonized Code
- The shipment tracking number
- Total number of packages in the shipment and total weight of the shipment
- Detailed description of each commodity
- Invoice total
- Signatures, the invoice must be signed and dated

What is a Certificate of Origin?

How do I determine if this shipment requires a Certificate of Origin?



### What is required for a Certificate of Origin?

- The shipper's name and address
- The recipient's name and address
- The product's parts or serial numbers
- The number of packages, boxes, or crates in the shipment
- The gross and net weight of the shipment
- A complete and accurate description of the contents of the shipment
- The country of origin of the contents of the shipment

### Electronic Export Information (EEI)

### Does your shipment require an EEI filing?

You must file EEI with FedEx International shipments from the U.S., Puerto Rico or the U.S. Virgin Islands to foreign destinations; between the U.S. and Puerto Rico; or from the U.S. or Puerto Rico to the U.S. Virgin Islands, if certain conditions apply.

### How do you file EEI?

If the shipment requires EEI data, there are two main options for filing:


- Self-file EEI directly to the U.S. Census Bureau's AESDirect website, a free internet application supported by the U.S. Census Bureau
- Authorize FedEx to file an EEI on the shipper's behalf using FedEx Export AgentFile® (A filing fee and certain limitations apply)






