

**FedEx Come In & Cash In Sweepstakes Official Rules**  
**No Purchase Necessary to Enter or to Win.**

- 1. Eligibility:** The FedEx Come In & Cash In Sweepstakes (“Sweepstakes”) is open to legal residents of the 50 United States or the District of Columbia who are 18 years of age or older as of date of entry. Employees of FedEx Corporate Services, Inc. (“Sponsor”), Don Jagoda Associates (“Administrator”), Hawkeye, Inc., Dollar General, and each of their respective parent and affiliate companies (collectively with Sponsor, Administrator, Hawkeye, Inc., and Dollar General, the “Promotion Parties”) as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Subject to all applicable laws and regulations. Void where prohibited. Eligible persons who participate in the Sweepstakes will be referred to as “Participant”, “you” or “your” in these Rules. Participation constitutes Participant’s full and unconditional agreement to these Official Rules and Sponsor’s and Administrator’s decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 2. Sweepstakes Timing:** Sweepstakes begins at 10:00 a.m. Eastern Time (“ET”) on December 1, 2021 and ends at 5:00 p.m. ET on January 31, 2022 (“Sweepstakes Period”).
- 3. How to Enter the Sweepstakes: There are two (2) ways to enter the Sweepstakes:**

- 1.) During the Sweepstakes Period, as an eligible Participant, you can register at <http://fedex.com/comeincashin> by completing all required fields of the onscreen registration form. Once registered, you will earn an entry for every FedEx package that you pick up or drop off at a participating Dollar General location during the Sweepstakes Period. To complete each entry, you must submit the tracking number on <http://fedex.com/comeincashin>. Once registered, you may return to the website and log additional tracking numbers. You may log a maximum of ten (10) tracking numbers per site visit.
- 2.) **Mail-in Entry:** If a Participant does not wish to pick up or drop off packages but would like to enter the Sweepstakes, Participant may hand-print their full name, full address, date of birth, and email address on a 3" x 5" piece of paper and mail it in a separate hand-addressed, stamped envelope with sufficient postage to be mailed to: The Come In & Cash In Sweepstakes, P.O. Box 7770, Melville, NY 11775- 7770. Limit one (1) mail-in entry per envelope. Each mail-in is equivalent to one (1) Sweepstakes entry. All mail-in entries must be complete to be eligible. All mail-in entries must be postmarked by January 31, 2022 and received by February 7, 2022 to be eligible. Mechanically reproduced or automated mail-in entries are not eligible.

Limit two hundred (200) entries per Participant, regardless of method of entry or combination of methods of entry. In the event of a dispute as to any entry, the authorized account holder (as determined by Sponsor) of the email address used to register for the Sweepstakes will be deemed to be the Participant. Normal internet access and usage charges imposed by your internet service provider will apply. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. All entries become the property of the Sponsor and will not be returned.

- 3.) **Prizes:** **Grand Prize (1):** \$5,000, awarded in the form of a check. **First Prizes (10):** \$2,000, awarded in the form of a check. **Second Prizes (100):** a \$50 Dollar General gift card. Gift card terms and conditions apply.
- 4.) **Drawing:** The winners will be selected in a random drawing on or about February 15, 2022, from among all eligible entries received/postmarked during the Sweepstakes Period. Drawing will be conducted by the Administrator (at their office in Melville, NY), an independent judging organization whose decisions are final on all matters relating to this Sweepstakes. Odds of winning a prize depend upon the total number of eligible entries received/postmarked during the Sweepstakes Period. Prizes will be awarded and winners will be notified by the Administrator.
- 5.) **General Rules:** Sponsor reserves the right to substitute a prize of equal or greater value if any advertised prize is unavailable for any reason. No substitution or transfer of prize by Participant/winner is permitted, other than as described above. Taxes related to the prizes are the responsibility of the winners. Grand and First Prize winners will need to provide their social security number for tax reporting purposes. Each potential Grand and First Prize winner will be required to execute and return, via email, a declaration of eligibility and liability/publicity release (where legal) (“Declaration package”) within five (5) days of attempted notification, or the prize may be forfeited and an alternate winner will be selected. Second Prize winners will be emailed for their mailing address and to confirm eligibility and must reply to the email within five (5) days of attempted notification, or the prize may be forfeited and an alternate winner will be selected. The Promotion Parties are not responsible for lost, late, illegible,

mutilated, misdirected or postage-due mailed entries; technical, hardware or software malfunctions; telephone failures of any kind; lost or unavailable network connections; or failed, incorrect, inaccurate, incomplete, garbled or delayed electronic or other communications, whether caused by the sender or by any of the equipment or programming associated with or utilized in this Sweepstakes, that may limit the ability to participate, or whether caused by any human error that may occur in the processing of the entries in the Sweepstakes. Sponsor reserves the right, at its sole discretion, to modify or cancel the Sweepstakes if it is technically corrupted in any way or if there are any situations that may arise (including, but limited to, acts of God, war, pandemics, natural disasters or weather-related), at its sole discretion, and award the prizes from among all eligible entries received/postmarked prior to cancellation (if any are received). Acceptance of a prize constitutes permission to use each winner's name and photographs/videos/testimonials for promotional purposes without further compensation or permission except where prohibited by law, without further compensation or permission from winner. The Promotion Parties will have no liability or responsibility for any claim arising in connection with participation in this Sweepstakes or use of any prize that is awarded and assume no responsibility for any injury or damage to Participants or to any other person's computer relating to or resulting from entering this Sweepstakes. By receipt of prize, each winner agrees to release, indemnify and hold harmless the Promotion Parties from and against any claims or causes of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of any prize ("Claims"). By participating in this Sweepstakes, each Participant agrees to be bound by these Official Rules and the decisions of the Sponsor/Administrator.

- 6.) **Disputes:** Participant agrees that: (a) he/she releases and will defend, indemnify and hold harmless the Promotion Parties from and all any and all Claims; (b) Claims arising out of or connected with this Sweepstakes, or the prize awarded shall be resolved individually, without resort to any form of class action, and solely and exclusively in a federal or state court located in western Tennessee, Shelby County; (c) Participant submits to sole and exclusive personal jurisdiction to said courts in the State of Tennessee for any such dispute and irrevocably waives any and all rights to object to such jurisdiction; (d) any and all Claims, judgments, and awards shall be limited to actual damages of no more than \$100, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (e) under no circumstances will Participant be permitted to obtain awards for and Participant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of Participants or the Promotion Parties in connection with this Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of Tennessee, without giving effect to any choice of law or conflict of law rules of provisions (whether of the State of Tennessee, the United States, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Tennessee.

The Participant agrees to the collection, processing and storage of his or her personal data by Sponsor for purposes of the Sweepstakes. By selecting the option to receive promotional emails from Sponsor, Participant agrees to receive future emails from any FedEx Operating Company.
