These surcharges will be in addition to existing charges. See the table below.

<p>Additional Handling Charges: Express Package and Ground Services, surcharge applies to any package that:</p> <p>[Dimension] 1) Measures > 48 inches along its longest side. 2) Measures > 30 inches along its second longest side.</p> <p>[Weight] 3) Has an actual weight > 50 lbs. (FedEx U.S. Express Package Services and U.S. Ground Services) 4) Has an actual weight >70 lbs. <p>International Out-of-Delivery-Area Surcharge and International Out-of-Pickup-Area Surcharge</p> <p>Currently, shipments delivered to or picked up from remote and less-accessible locations outside the U.S. are assessed an International Out-of- Delivery-Area Surcharge or an International Out- of-Pickup-Area Surcharge.</p> <p>View a list of postal codes or cities where these surcharges currently apply.</p>	<p>Effective Jan. 18, 2021, certain international shipments to/from the U.S. are assessed an International Out-of-Delivery-Area Surcharge or an International Out-of-Pickup-Area Surcharge for International Express Freight services based on ZIP code location of the pick-up or delivery.</p> <p>See the International Out-of-Delivery-Area Surcharge and International Out-of-Pickup-Area Surcharge ZIP code changes PDF for a list of the ZIP codes where these surcharges apply. <p>Fuel Surcharge for U.S. Domestic Express Freight</p> <p>For FedEx Express, the fuel surcharge is a percentage assessed on the net package rate plus applicable surcharges. The fuel surcharge percentage is subject to weekly adjustment based on the weekly U.S. Gulf Coast (USGC) spot price for a gallon of kerosene-type jet fuel, as published by the U.S. Department of Energy. The surcharge now in effect applies to all FedEx Express® U.S., U.S. export and U.S. import shipments, except for FedEx International Express Freight® and FedEx International Airport-to-AirportSM shipments.</p>	<p>Effective Feb. 1, 2021, the fuel surcharge for U.S. Domestic Express Freight services will be a charge per pound assessed on the rated weight of the shipment. The charge per pound will be subject to weekly adjustment based on the weekly published U.S. Gulf Coast (USGC) spot price for a gallon of kerosene-type jet fuel.</p> <p>Preview the fuel surcharge table effective Feb. 1, 2020.</p>
